- 2. There are many kinds of new farmers
- 3. Agriculture is a unique industry
- 4. Use buckshot, not silver bullets
- 5. Focus more on financial security, less on food security
- 6. Demand the province do more

Rural communities require real people

- 55% of farmers in Northern BC use a computer, 32% have hi speed internet
- O Average attendance at a community workshop: 10
- Average attendance in similar webinars: 0
- Make hard copies, always
- Train local experts to teach
- Never build a business plan without a vested entrepreneur
- Offer 1-to-1 programming. Not everything can be done as a group

The are many kinds of new farmers

- Next Generation Farmer strong working knowledge through family or employment, sometimes lack management skills. Often a desire to redefine inherited operations.
- Elder Transition Farmer old farmer, new business. Often exceptional knowledgeable but very cynical
- Greenhorns minimal working knowledge, sometimes bring unique knowledge from other careers
- Future farmer no experience, no assets, lots of dreams. Low success rate
- Rural retirement dream farmer Like a greenhorns but with more money and career/life experience, less motivation
- New Canadian recent immigrants, many with ag experience in home country or with strong network ties to ethnic consumer in Canada. Less common in BC interior

Agriculture is a unique industry

- In 2015, total sales across entire industry in BC were \$13 billion and represented 2.1% of GDP with 57,000 resident workers
- In 2015, total sales of just primary production in BC were \$3.1 billion and represented 0.6% of GDP with 21,000 resident workers
- Exceptional year-to-year growth rate, outpacing all other resource industries.
- O BC's 5th largest export industry, next to forestry, minerals, energy and machinery
- Characterised by 1000's of operators all across the province (20,000 farms in 2011)
- O BC Ministry of Ag budget in 2017/2018: \$82 million
- O BC Ministry of Forests budget 2017/2018: \$671 million

Northern BC: more than you imagined

- 4,000 farms, 21% of BC total
- Roughly 2% of population are farmers
- 10% of gross provincial sales
- 1000 employee FTEs
- 70% of ALR lands

- 90% of bison in BC
- 71% of alfalfa acreage in BC
- 62% of hay acreage in BC
- 45% of cattle in BC
- 40% of horses in BC
- 30% of sheep in BC
- 20% of dairy animals in BC
- 2% of vegetable acreage

Use buckshot, not silver bullets

Focus on financial security

- Story of the free farmer
- O Story of the 100 mile diet
- Why you should eliminate all barriers to participation

Demand that the Province do more

- Five years of successful programming in a rural and vast region
- Cobbled together on a shoestring budget with mainly regional district funds
- Multiple requests across the province for similar programming
- Spring 2015: Beyond the Market drafts a provincial proposal for community-based agriculture extension services
- In brief: A \$330,000 project, to be administered independently in six regions, providing similar services as Beyond the Market

Demand that the Province do more

- August 2015: Presentation to the Ministry of Agriculture and Ministry of Jobs, Tourism and Skills Training
- September 2015: Presentation to the Standing Opposition Committee for Agriculture
- October 2015: Submission to the Provincial Select Standing Committee on Finance and Government Services
- October 2015: Submission of 23 letters of support to Minister of Agriculture, the Minister of Jobs, Tourism and Skills Training
- O December 2015: Submission of request for formal response
- O January 2015: Continued requests for meetings and formal responses
- O March 2016: A meeting with Ministers Bond and Morris to re-present the original request made in August 2015
- O April 2016: Request to NCLGA to adopt a resolution supporting community based extension program denied
- O June 2016: Request to UBCM to adopt a resolution supporting community based extension program denied
- September 2016: UBCM resolution endorsed. Ministry of Ag announces \$250,000 for a gardening program
