BC Communities in Bloom

BC Communities in Bloom (BC CiB) is a province-wide recognition and award program that provides a framework for Municipal participants to reinvigorate and enhance their community's liveability.

Using the collaborative power of local government, business/institutions, service clubs and residents, it is this 'Growing Together' that stimulates civic pride and encourages tidiness, beautification and environmental initiatives throughout their area. The program inspires a 'transformation' process that can have lasting social, environmental and economic benefits.

In annual surveys of participants, beautification is listed as the top improvement, with tidiness a close second. Other benefits noted were property values and improved green spaces, with lifestyle, environmental, tourism and safety rounding out the list of valued improvements.

BC CiB trained volunteers visit the participating community to evaluate specific criteria with a standardized scoring matrix. The purpose of the report is to provide feedback on the visual appeal of streetscapes, public green spaces, neighbourhoods, and to preserve heritage and cultural assets. The report can then be used to celebrate excellence and areas for improvement year over year. Whether a community's objective is to enhance tourism experiences or improve liveability for their residents, the CiB program is a tool to achieve these goals.

- Canada-BC Agri-Innovation Program: Enables B.C.'s agriculture and food sectors to accelerate the pace of innovation. Allows the sector to access funding for projects involving late-stage research and development; piloting and demonstration; as well as the commercialization and adoption of innovative products, practices, processes or technologies. \$14M from 2018-2023.
- BC Agri-food and Seafood Market Development Program: Enables B.C.'s agriculture, food and seafood sectors to pursue interprovincial and international market opportunities. \$5M from 2018-2023.
- Tree Fruit Competitiveness Fund: Supports B.C.'s Tree Fruit sector to undertake marketing, infrastructure and research activities that enhance the competitiveness of the sector. The program also supplements orchard replanting. \$5M from 2018-2023. \$3.5M for projects and \$1.5M for orchard re-plant.

Ministry of Children & Family Development

To better meet the child care needs of families, the Province of British Columbia recently announced expanded investment in the child care sector totaling \$1.3 billion over three years. This includes \$237 million to improve access to child care, including funding to support the creation of 22,000 new licensed child care spaces.

Local governments can now access up to \$3 million per facility to create new licensed child care spaces through the Childcare BC New Spaces Fund.

- Waste Diversion initiatives and new programming that support reduced landfill dumping of materials, including organics that can be used to create energy and reduce carbon pollution
- Energy ministry programming supports local governments and Indigenous communities transitioning their energy systems toward cleaner, low-carbon options, e.g. Climate Energy Leadership Program Community Energy Solutions such as efficiency retrofits and district energy and Clean Energy Vehicle Charging Infrastructure Program
- To support capital expenditures on improvements to community infrastructure funding is being made available to municipalities and indigenous communities via the federal Investing in Canada Infrastructure Program (see also: Active Transportation; Transportation & the Environment)
- CleanBC's Better Homes/Better Buildings is B.C.'s online hub for homeowners and businesses to access information, rebates and support to reduce energy use and greenhouse gas emissions in new and existing homes and buildings

Railway Accidents Involving Crude Oil Fund

This Fund for Rail Accidents Involving Crude Oil (the Fund) covers damages to victims of a major crude-by-rail accident. Compensation starts after railway companies have paid up to the amount of their minimum insurance requirement.

Following the 2013 derailment in the town of Lac-Mégantic, the federal government strengthened the liability and compensation regime for rail accidents involving crude oil by: holding railways involved in crude oil accidents liable for damages without needing to prove fault or negligence and requiring minimum insurance levels based on the risk, type and volume of crude oil they transport.

The independent Administrator of this federal Fund is implementing an action plan to facilitate access to justice and compensation for victims. Now, in the event of a railway accident involving crude oil, the Fund will protect Canadians from bearing the cost of damages.

The Ship-source Oil Pollution Fund (the Fund) has been compensating victims of oil pollution from ships for 30 years. This federal Fund managed by an independent Administrator, assesses claims for damages from any type of oil from any ship or boat, anywhere in Canadian waters.

In case of damages, local governments such as municipalities, cities, villages, townships and Indigenous communities can submit claims for: clean-up costs and preventive measures. property damages, costs for rehabilitating damaged environments, economic losses and more.

Submitting a claim to the Fund can spare local governments from having to take costly legal proceedings. As soon as the Fund has paid for the damages you incurred, they are taking all reasonable steps to recover costs from polluters or other liable parties.

Community Child Care Planning & Space Creation Programs (Table 9)

In order to better meet the child care needs of families, the Province of British Columbia recently announced expanded investment in the child care sector totaling \$1 billion over three years. This includes \$237 million to improve access to child care, including funding the creation of 22,000 new licensed child care spaces.

The Ministry of Children and Family Development is providing \$3 million for the Community Child Care Planning Program. Community Resiliency Investment Program (Table 7)

The Community Resiliency Investment (CRI) program is intended to reduce the risk and impact of wildfire to communities in BC through community funding, supports and priority fuel management activities on provincial Crown land. The program was launched in 2018 and 128 First Nations and local governments have received funding.

The UBCM, First Nations' Emergency Services Society and the Forest Enhancement Society of BC are working with the Ministry of Forests, Lands, Natural Resource Operations & Rural Development, represented by the BC Wildfire Service, to administer the FireSmart Community Funding & Supports portion of the program for local government and First Nation applicants.

The CRI provides the following resources:

 2020 FireSmart Community Funding & Supports – Application Deadline October 18, 2019

The 2020 program is structured to fund FireSmart activities in all eligible communities throughout BC. Funding is scaled to offer eligible applicants with lower risk of wildfire to apply for up to \$25,000 and applicants with a demonstrated higher risk of wildfire to apply for up to \$150,000 per year.

Gas Tax Management (Table 8)

The federal Gas Tax Agreement (2014-2024) is a tri-partied agreement between the federal government, the province, and UBCM. UBCM administers the Gas Tax Fund in British Columbia and, over the term of the Agreement, will oversee the transfer of more than \$3 billion of federal funding to local governments and eligible recipients for infrastructure and capacity building projects.

During the term of the Gas Tax Agreement, local governments are required to work to strengthen their asset management practices, in accordance with the Asset Management for Sustainable Service Delivery: A BC Framework. As part of this requirement, local governments are required to commit to asset management practices, and report on those activities to remain eligible for Community Works Funds.
