BC Transit

• Provincial authority responsible for the planning, funding and operation (marketing, fleet, scheduling, planning) of all transit service throughout the Province outside of Metro Vancouver



Service Delivery

Conventional Transit

- Fixed routes & schedules
- Mainly urban settings

Custom Transit (handyDART)

- Door to door; demand responsive
- <u>Eligible</u> people with a disability





Flexible Transit


- Flexible routing and schedules
- Small towns, and rural communities


Regional Connector Services

- Links to remote and smaller communities
- Access to healthcare, services and amenities



Funding & Governance







Rural Transit - Characteristics

Communities Served

- Lower population densities
- Operating conditions can be harsh (weather & roads)
- Often involves multiple jurisdictions

Service Provision

- Basic coverage
- Lower trip frequency
- Light duty buses

Ridership Performance

- Lower rides per hour
- Lower cost recovery through farebox revenue



Rural Transit - Benefits

Economic

- Supports local business & community sustainability
- Brings shoppers to stores and supports downtown cores
- Provides access to health care and education services

Mobility

- Provides options for workers, students, tourists
- Seniors (aging in place), low-income, persons with disabilities

Environment

• Supports climate change strategies





Rural Transit - Challenges

Customers

- Travel distances and duration
- Parking convenient and inexpensive
- Prioritizing key markets

Local Government Funding

- Competing with other community needs
- Financial sustainability

Supportive infrastructure

- Potential service providers
- Suitable vehicle maintenance and storage
- Bus stops & shelters





Examples

Powell River Regional Transit

- Partnership with qathet Regional District
- Service to Electoral Areas and Tla'amin First Nation
- Off route deviations to "Byrequest" service areas
- Service to Texada Island service uses BC Ferries to provide onisland service






Examples

Bulkley Nechako Regional Transit

- Partnership with Regional District of Bulkley-Nechako
- Launched in 2017 as a key component of the Highway 16 Transportation Action Plan
- Provides return, same-day service to nearest regional centre




Opportunities
