





- Look at ways the RDCO and WFN could collaborate to protect these sites.





Partnership Highlights

- Memorandum of Understanding for the Protection and Conservation of Cultural Heritage Sites in Regional Parks
 - Key Objectives:
 - Identify and document all known archaeological sites within regional parks,
 - To protect the integrity of archaeological and cultural sites within our parks,
 - To educate the public about WFN traditional use of these sites, WFN language and their culture through;
 - Co-managing cultural heritage sites within our regional parks,
 - Collaborating in the design of future regional parks plans,
 - Incorporate sylix language on interpretive signs and information kiosks,
 - Hiring park interpreters from Westbank First Nation or the Okanagan Nation Alliance

What's the Role of the EA Director in This?

- Support your corporate communications protocols,
- Get to know the First Nations communities in your Electoral Area,
 - Learn their history, their culture, their issues;
 - Invest in the time to build a strong working relationship based on mutual respect and trust;
 - At the appropriate time advocate for a C2C Forum to help formalize your working relationships;
 - Through casual conversation see if there are ways to advocate, innovate, and collaborate on issues that matter;
 - Work with your Board Chair, CAO and others on how best to take steps towards reconciliation.

Recent Point of Interest

- Bill 41 received royal assent in BC on November 28th, 2019:
 - United Nations Declaration on the Rights of Indigenous Peoples
 - critical step forward on the path to reconciliation,
 - Over time, it is expected there will be further legislative changes to align existing BC laws with UNDRIP principles.
