

Whether do a village of 500 people and a city of over 500,000 or a highly urbanized metropolitan region and a rural district have in common? They share a need for effective and accountable local government – the foundation of a democratic society. They want a way of meeting the needs of their communities in the best way possible.

One of the ways local governments can work toward getting the "tools" to do their job is by joining together with other local governments. Since 1905, the common interests of local government in B.C. have been brought together in the Union of British Columbia Municipalities (UBCM).

Membership in the UBCM is voluntary – but all municipalities and regional districts are members. UBCM works in two ways to meet the needs of members.

## REPRESENTATION

REPRESENTATION of local government concerns to other orders of government.

## MEMBER SERVICES

MEMBER SERVICES that are provided to all members and some services that members select to participate in.

Delegates from member municipalities and regional districts provide the broad direction for the UBCM at its annual convention. Responsibility to carry out that direction is given to an Executive Board that includes representatives of the five area associations.

The UBCM has grown and become involved in more activities than when it was established in 1905, but the tradition of building local government that can best serve our communities remains.



## REPRESENTATION

The UBCM was formed to provide a common voice for local government and this role is as important today as it was when established years ago. The UBCM reflects the truth in the adage's "Strength in numbers" - "united we stand - divided we fall."

The UBCM Convention continues to be the main forum for policy-making. It provides an opportunity for local governments of all sizes and from all areas of the province to come together, share their experiences and take a united position.

Positions developed by the members are carried to the provincial and federal governments and others involved in local affairs. Policy implementation activities have expanded from annual presentations to the Cabinet, to the present day where UBCM is involved in intergovernmental committees, regular meetings with Ministers and contact on a daily basis with other orders of government. Direction provided by members is carried forward by an Executive Board and staff secretariat.

In today's ever-changing world, where shifts in other orders of government policies, or in economic, social or political conditions can have an immediate effect on local government, UBCM stands as a "listening post." UBCM initiates, monitors, interprets and reacts where such changes could have an effect on local governments and the communities they serve.

The result is that local government is more effective and B.C.'s communities are the real winners. Through the UBCM local government has many achievements, and the potential is there to achieve even more in the future.
