

LETTER OF TRANSMITTAL TO UBCM MEMBERS

It is a pleasure to present the 2013 Annual Report to the membership of the Union of BC Municipalities.

UBCM's agenda over the past year has been dominated by several projects that directly address the broad interests of BC local governments.

The negotiation of the federal government's Long Term Infrastructure Plan was a key focus for our work leading into last year's Convention. UBCM worked closely with FCM, along with the federal and provincial governments, to make sure that the policies endorsed by our membership were heard and understood. Several elements in the federal government's plan, including greater scope and an index for the Gas Tax Fund, directly address UBCM resolutions and survey feedback.

With the Long Term Infrastructure Plan now announced, UBCM has been reaching out to the membership to solicit feedback on program design for the renewed Gas Tax Agreement. UBCM staff and Executive members have met with Tier 2 regions and Metro Vancouver. In July we also released a survey to draw in additional information from Tier 1 communities. We expect this file to be quite active for UBCM over the coming months.

Another priority in our work this year has been the Select Committee on Local Government Finance. The committee was appointed by UBCM Executive in 2012 and has been working towards delivering a policy paper to the 2013 Convention. The committee received solid input from the membership during their presentations at Area Association meetings. Mr. Dale Wall, with his extensive experience within the provincial government, has also provided invaluable assistance in the drafting of the report. We look forward to the discussion during our policy session at Convention.

The other key initiative from this year was an ambitious plan for engagement with the four main political parties during the recent provincial election. The Executive identified the need for an election platform during its priority setting exercise in the fall. The result was a broad themed document that received considerable attention from all four parties and provides context for UBCM's post-election advocacy with the provincial government.

These are just four highlights from our year. There is much more to be said, the details of which you will find in the following report. It is a great honour to work on behalf of all BC local governments, and we look forward to seeing you at the 2013 Convention where we will gather under the theme of "Navigating the Local Landscape."

Union of BC Municipalities was incorporated by an Act of the provincial legislature in 1959. 2012-2013 UBCM ACCOMPLISHMENTS IN BRIEF¹

TOP ACTIVITIES OR INVOLVEMENTS

- 100% of eligible local governments maintained membership for the 34th consecutive year
- UBCM established a Select Committee on Local Government Finance to explore the fit between the broad range of services offered by local governments and existing revenue tools available to them. A report from the Select Committee will be presented to the 2013 Convention for member consideration
- designed and implemented an extensive and ambitious provincial election strategy that identified and conveyed key UBCM priorities, analyzed main party platforms, and secured party responses to UBCM's platform. UBCM's election platform document, Building Tomorrow Together, was used to engage all provincial political parties and the UBCM membership
- in collaboration with FCM and local government members, extensive work undertaken and submission made to the federal government in response to the announcement of a long term infrastructure program being established
- 93% of respondents to UBCM's triennial member satisfaction survey ranked UBCM as very important or important; and 75% of respondents felt that they got excellent or good value for money with their UBCM membership
- seventh year of Local Government Leadership Academy training – forum held to piggyback on Electoral Area forum
- extensive outreach undertaken with the membership on program design for the renewed Gas Tax Agreement. Member consultations undertaken with Tier 2 regions and Metro Vancouver; and surveyed Tier 1 communities for feedback
- total funding received by UBCM under Gas Tax Program reaches \$1.39 Billion
- UBCM, LGMA, CivicInfo BC, BC School Trustees, Public Works Association of BC and the Province join together to host the fourth year of the renewed Local Government Awareness Week program – May 19-25, 2013
- major advancements made to streamline UBCM communications with the launch of The Compass – our new, weekly e-news communication and UBCM enters the social media world by establishing Twitter accounts
- established local government working groups to

support implementation of key policy initiatives including the BC Transit Independent Review and the 911 Wireless Call Answer Levy.

ADVOCACY

Policy Development and Implementation

A top priority is to advocate on behalf of BC local governments for the development of policies that support their needs and to see them implemented in legislation, regulations, programs or policies. UBCM participates in policy development in a number of ways: independent initiatives and making representations directly; and participating in Ministry–UBCM or multi-party policy development processes. The issues are many and varied and some have required sustained involvement, while others may only have required limited intervention.

Policy Development

PROVINCIAL GOVERNMENT ADVOCACY

- participated in first Justice Summit organized by the Province and provided comments on several reports released on the justice system
- provided advice on the delivery of fire services in the Province

- provided feedback on the new Community Safety Act
- participated in discussions on the development of a Provincial road safety strategy
- participated in discussions on the need for changes in floodplain management to address the impact of climate change and the need for a Province wide floodplain management plan
- organized a local government working group to examine the implementation of a Province wide call answer levy on wireless services to fund the next generation of 911 services

Finance

- continued to participate in the Development Finance Review Committee
- provided advice to the Auditor General for Local Government and the Audit Council, through presentations and participation in a workshop, with the aim of furthering local government interests in ensuring the Office operates within its legislative mandate, and that its activities are undertaken with a full understanding of local government legislation, operations and capacity
- established a Select Committee on Local Government Finance, with a mandate to report out to Executive on whether revenue tools available to local governments are appropriate given the range of services they now deliver, and if not, to make recommendations for change
- convened seven meetings of the Select Committee, to develop a workplan, analyze the system of local government finance in BC, consider revenue options, and develop a report to Executive
- consulted with the membership in relation to local government finance issues through a workshop at each of the Area Associations
- spoke at the Metro Vancouver Finance Symposium on Local Government Finance, and the Metro Vancouver Sustainability Community Breakfast on Paying for our Cities
- developed a Policy Paper on Local Government Finance for the 2013 Convention
- participated in Municipal Pension Plan Partners Committee

Health

- continued to participate on the Provincial Health Services Authority's Healthy Built Environment Alliance
- continued to participate on the BC Healthy Living Alliance
- co-chaired the Emergency Medical Assistants Education Fund Advisory Committee which

aims to increase the number of Primary Care Paramedics (PCP) in rural areas, and Advanced Care Paramedics (ACP) in BC, through the provision of student bursaries

- worked with the Ministry of Children and Family Development to introduce a poverty reduction pilot project in 7 BC communities
- became a member of the BC Physical Activity Leadership Table which is developing of a BC physical activity strategy and action plan
- provided feedback on the Ministry of Health's Guiding Framework for Public Health and the Province's 2013/2014 public health priorities
- continued to support and provide feedback on the development of the Healthy Families BC Communities initiative

- continued the work of the UBCM Packaging and Printed Paper (PPP) Working Group, and advised on local government concerns around the design and implementation of the PPP stewardship plan
- provided support and direction for the development of provincial subdivision and sewerage best practices guidelines
- advised on BC's Five Year Plan for Species at Risk through continued participation on the Species and Ecosystems at Risk Local Government Working Group
- continued participation in the work of the Green Communities Committee, focusing on the development of the BC Protocol for the Creation of Forest Carbon Offsets and the updated Becoming Carbon Neutral Guide for Local Governments in BC
- provided feedback on the Ministry of Environment's Land Based Spill Preparedness and Response in British Columbia Intentions Paper and became a member of the provincial Land Based Spill Advisory Committee
- consulted as a stakeholder in the Ombudperson's investigation of the Riparian Areas Regulation

- advised on the development of the provincial Tsunami Debris Management Plan through participation on the Tsunami Debris Co-ordinating Committee

- continued to monitor Canada-European Union Trade Agreement (CETA) negotiations

- provided feedback on the Province's Business Attraction Toolkit for BC communities
- made submission to the Special Committee on Timber Supply

- met with NetworkBC on their role in expanding broadband connectivity throughout the province
- convened engagement session with DFO on Fisheries Act changes; provided information to members on amendments; seeking feedback from local governments on impact of changes; coordinating member comments
- secured local government representation on federal Aquaculture Management Advisory Committees
- continued participation on the Natural Resource Roads senior advisory team

Infrastructure

- surveyed the membership on infrastructure matters
- participated in the BC Long-Term Infrastructure Plan (LTIP) roundtable
- participated in senior officials meetings regarding the permanent Gas Tax program
- developed and delivered a submission to Infrastructure Canada on the Long-Term Infrastructure Plan
- reported to the membership on infrastructure discussions through member releases, a pre-conference finance session, and Compass articles
- participated in a joint Provincial/UBCM LTIP working group
- delivered a LTIP update to the 2013 Local Government Leadership Academy Forum
- coordinated infrastructure advocacy efforts with FCM
- presented to the federal BC Conservative Caucus on the current Canada-BC-UBCM Gas Tax Agreement
- met with Minister Bennett and Mayor Moore, Metro Vancouver Chair, on permanent Gas Tax arrangements for the Metro Vancouver region
- met regularly with provincial and federal Gas

Tax program staff

- convened a joint Metro Vancouver/UBCM workshop to consult with Metro Vancouver and its member municipalities on the renewed Gas Tax Agreement

- continued involvement with the Off-Reserve Aboriginal Action Plan (ORAAP), with First Nations Relations Committee Chair Murry Krause appointed to the ORAAP Provincial Coordination Team
- corresponded with Minister of Aboriginal Affairs and Northern Development Canada and Standing Senate Committee on Aboriginal Peoples, requesting an opportunity to discuss the status of the ATR policy review and communicate local government concerns around the policy and associated land transfer procedures

- undertook discussion with MARR regarding a potential local government involvement in Strategic Engagement Agreements

Transportation

- discussed Greyhound cuts in service, identified impacts throughout the membership and convened meeting with UBCM Executive and BC Passenger Transportation Board to express concerns

UBCM’s policy initiatives are primarily derived from resolutions submitted by members. During 2013, UBCM reviewed many high quality, clearly written and well-researched resolutions in the course of preparing the Annual Report and Resolutions Book. All Area Associations submitted their resolutions for UBCM comment prior to their annual meetings and subsequently conveyed endorsed resolutions to UBCM for consideration at the 2013 Convention.

UBCM RESOLUTIONS RESPONSES

A total of 138 resolutions were forwarded to the provincial government for consideration following the 2012 UBCM Convention. In addition, 37 resolutions were conveyed to the federal government; 21 were conveyed to the FCM; and 16 were conveyed to other organizations. Responses have been conveyed to the resolution sponsors and posted to the UBCM website.

The Province has indicated that 61 issues raised in the 2012 resolutions have already been addressed in whole or in part by provincial initiatives and noted that it was not willing to consider changes proposed in 42 of the resolutions. Provincial support was noted in the case of two resolutions and the Province indicated it is willing to consider the changes/suggestions/concerns expressed in thirteen more resolutions. Further review and/or action will be undertaken on the changes suggested in 26 resolutions. As well, UBCM is already working with the Province on eleven resolutions and will monitor provincial action in several other policy areas. The Province deferred two resolutions to other organizations.

PRESIDENTS

The mandate of the Presidents Committee is to provide direction and oversight to the UBCM Secretariat as it strives to continually improve the organization's effectiveness. That mandate translates operationally in a variety of ways, depending on the priorities set by the Executive each year.

One of the activities pursued in 2012-13 was the development of an ambitious and proactive Provincial Election strategy. Under the guidance and direction of the Presidents Committee, the Building Tomorrow Together Platform document was created, along with an outreach strategy for engaging provincial parties and the broader UBCM membership. Responses to the Platform document were actively sought from all four parties and posted to the UBCM website; follow-up meetings were requested with party leaders and party platforms were analysed for linkages to the UBCM priorities. The Committee will continue to direct post-election work that will marry up UBCM priorities with those of the newly elected government.

Other strategic files benefiting from oversight by the Presidents Committee included: the implementation of the Auditor General for Local Government; the Select Committee on Local Government Finance; and the UBCM's response to the federal government's commitment to legislate a permanent gas tax program.

In addition to providing overall management responsibility for UBCM affairs between Executive meetings,

the Committee took on some specific tasks this past year:

- launched the Compass - weekly e-news on UBCM activities and moved UBCM into the social media realm with the establishment of 'twitter' accounts.
- continued to provide support to FCM's Municipal Partners in Economic Development program – UBCM has a partnership with Vietnam that resulted in one mission to Vietnam and one mission to BC this past year.
- amended Executive policies to extend complimentary Convention registration privileges to all Life Members, in or out of office, recognizing the valuable contribution that many Past Presidents, still serving in elected office, continue to make to UBCM.
- amended UBCM's Code of Conduct to address Executive member leaves of absence when seeking provincial or federal elected office, making it clear that if successful in securing a nomination a board member must take a leave of absence, and if successful in the election, a board member must resign from the Executive. If unsuccessful, a board member may return to the Executive.
- undertook the triennial member satisfaction survey to seek feedback on a number of UBCM activities and programs provided to local governments and assists the Committee in determining where the organization is excelling and where there is need for improvement.
- directed that a comprehensive review be undertaken of Executive Policies with a view to updating and making the policies more current with established UBCM standards and practices.

The Presidents Committee also acts as the Audit Committee and oversees UBCM’s year-end audit and budget setting process. The Committee also provides oversight to the Excellence Awards program, UBCM’s Member Services and Group Benefits Programs, Local Government Awareness Week and serves as the contact point for UBCM representatives to the Municipal Pension Plan.

CONVENTION

The 2012 Convention was held in Victoria from September 24 to 28, and adopted an “In Conversation” theme. A total of 2,065 delegates attended the Convention, representing

193 UBCM member communities from all across the province. The Convention received a strong 4.2 out of 5.0 rating for the second year in a row.

A variety of tours and sessions were held this year on topics ranging from marijuana decriminalization to local government finance. Programming also included a diverse range of clinics and workshops, including “Powers of Mayor and Council”, “First Nations Participation as Members of Regional Districts”, and “Developing Your Volunteer Fire Department”. As always, delegates had the opportunity to set policy through Resolutions sessions, and participate in a number of Provincial Policy sessions, Cabinet Panels and government meetings.

RESOLUTIONS

The annual resolutions process is the foundation of UBCM’s ongoing advocacy work on behalf of local governments in BC. Through resolutions, UBCM members speak with one voice to express the needs and concerns of BC communities. Issues raised and solutions proposed in resolutions often result in positive change for the membership.

Recent responses to UBCM resolutions provide examples of the success that we achieved through this process:

These are some recent success stories. Not all resolutions achieve immediate results, but they bring important local government issues to the attention of the provincial and federal governments.

In 2013, members’ concerns reflect a wide range of issues including flood management and emergency management; clarification of conflict of interest guidelines pertaining to local government elected officials; mitigation of human-wildlife conflict; emergency notification systems; policing in small and rural communities; use and assessment of agricultural land; and access to health services.

PRIORITIES

- Continue to work with the Ministry of Health Services and the Ministry of Community, Sport and Cultural Development on addressing local government concerns around small water systems through the UBCM Small Water Systems Working Group
- Continue to work with the senior orders of government on developing debris management plans that address local government concerns around Japanese tsunami debris
- Conclude the work of the UBCM Packaging and Printed Paper Working Group in advising on the development of a packaging and printed paper product stewardship program which maximizes the recovery rate and provides the broadest choice of options for consumers
- Enhance water governance and management in British Columbia through participation in the Water Act Modernization process and the implementation of the Collaborative Watershed Governance Accord
- Continue to work with the Province on assisting local governments in meeting their Climate Action Charter commitments, including carbon neutrality
- Monitor and respond to ongoing and emerging environmental policy, legislative, and regulatory issues that affect local government

Over the past year, the Environment Committee has been actively monitoring and advising on a number of key environmental issues which impact the sustainability and environmental well being of local communities. From small water systems, to land-based spill responses, to the Recycling Regulation, the Committee has voiced local government concerns and recommendations on a number of key regulations, policies and plans designed to green BC's communities.

At the forefront of the Committee's work has been a series of water issues, including small water systems and collaborative watershed governance. The UBCM Small Water Systems Working Group continued to work with the Province to identify policy and regulatory options to address outstanding local government concerns with the Drinking Water Protection Act and related Drinking Water Protection Regulation. The Working Group developed financial best management practices guidelines to improve the financial sustainability of small water systems, as well as subdivision best management practices guidelines to address planning and servicing issues. The Committee has also been providing advisory support to the Collaborative Watershed Governance Initiative Steering Committee, which is seeking to implement an accord for more collaborative governance of British Columbia's watersheds.

In accordance with the policy recommendations adopted at the 2012 UBCM Convention, the UBCM Packaging and Printed Paper (PPP) Working Group has been working to advance local government interests

in the design and implementation of the PPP product stewardship plan. The Working Group has provided feedback on the product stewardship plan, advised on the market-clearing price financial incentives for the provision of packaging and printed paper collection services, and conducted a legal review as to whether local governments can be considered producers under the Recycling Regulation. Through collaboration with the Stewardship Agencies of British Columbia (SABC), the Committee has been exploring the creation of a joint UBCM – SABC advisory committee. The joint committee would seek to improve the performance and effectiveness of extended producer responsibility (EPR) programs in BC through greater engagement between local governments and stewardship agencies.

The Committee has also been proactively working with the Province on developing and implementing frameworks for protecting the environment from natural disasters and development activities. Through continued participation on the Tsunami Debris Co-ordinating Committee, UBCM has advised on Phase Two of the Tsunami Debris Management Plan.

Phase Two focuses on how the Province will work with coastal communities to assess and determine specific challenges associated with the collection, removal, and landfilling of tsunami debris.

As part of the five conditions for potentially supporting heavy oil projects, the Province has been reviewing industry-funded options

for strengthening BC's spill preparedness and response policies and capacity. The Committee has made recommendations with respect to the provincial intentions paper on land based spill response, and is a member on the Land Based Spill Response Advisory Committee.

Other initiatives undertaken by the UBCM Environment Committee include providing guidance on the creation of new subdivision – sewerage best practices guidelines, supporting provincial efforts for brownfield renewal and redevelopment, advising on the Province's 5-Year

Plan for Species at Risk, and sharing information on amendments to the Fisheries Act and changes to the environmental assessment process. The Committee has also continued to assist local governments in meeting their Climate Action Charter commitments through the development of a revised Becoming Carbon Neutral and Forest Offset Carbon Protocol.

Overall, the Environment Committee has been advocating local government interests on a wide range of regulations, policies, and strategies being devised and implemented by the Province to create and enhance sustainable "green" communities.

FIRST NATIONS RELATIONS: A YEAR IN REVIEW

The First Nations Relations Committee continued to monitor several key issues this term, including follow-up to the renewal of the 2012 MOU on Local Government Participation in the New Relationship between the Province of BC and UBCM. This included discussion regarding a potential joint education and outreach program including the development of a communications protocol, to aid in the consistent application of the principles of the agreement across ministries and local governments, while also ensuring that all parties are kept informed of the work that is underway regionally. While conducting preliminary work on communications protocol, other opportunities for collaboration developed for UBCM and the Ministry of Aboriginal Relations and Reconciliation (MARR). At its April meeting, the First Nations Relations Committee was asked to prioritize these projects, including the protocol, a potential intergovernmental staff working group on aboriginal issues and investigation of a Strategic Engagement Agreement pilot program. The Committee decided to postpone work on the communications protocol, in order to focus on these other key priority projects.

The Committee received several updates from MARR over the course of the year, especially regarding the Off-Reserve Aboriginal Action Plan. Councillor Murry Krause, 2012/2013 UBCM First Nations Relations Committee Chair, sits on the Provincial Coordination Team for ORAAP on UBCM's behalf. The purpose of ORAAP is to support off-reserve/urban aboriginal peoples and improve their social outcomes, and aligns with the federal government's Urban Aboriginal Strategy (UAS).

The Committee also met with the former Minister of Aboriginal Relations and Reconciliation, Ida Chong, as part of the UBCM Executive meeting in Victoria in January. The following issues were discussed: next steps for the 2012 MOU on New Relationship, 2012 resolutions SR1 and B32, Marpole Midden Site status, Bill S-8: *The Safe Drinking Water for First Nations Act*, and the status of the Regional Community-to-Community Forum Program. The idea of pursuing an intergovernmental staff working group was also raised by the Committee.

Much of the Committee's work this year focused on two key federal legislative initiatives: Bill S-8: *The Safe Drinking Water for First Nations Act* and the Federal Additions to Reserve Policy. This included a joint Metro Vancouver/UBCM delegation to Ottawa to speak to the House of Commons Standing Committee on Aboriginal Issues regarding Bill S-8. The delegation provided testimony relaying local government concerns regarding the bill, including lack of local government consultation, regulatory and jurisdictional concerns, as well as transfer of responsibility and liability, and was invited by the Standing Committee to propose specific amendments. These amendments were provided to the Standing Committee prior to its line-by-line review of the bill. Since the time of this work, the bill has passed. Consequently, UBCM will continue to monitor the legislation and correspond with AANDC regarding local government consultation and engagement during regulation development and implementation.

The Committee has also continued to monitor the federal review of the Additions to Reserve (ATR) process. Chair Krause wrote to the former Minister of Aboriginal Affairs and

FIRST NATIONS RELATIONS: A YEAR IN REVIEW

Northern Development Canada, John Duncan, and Chair Vernon White of the Standing Senate Committee on Aboriginal Peoples, requesting an opportunity to discuss the status of the current ATR policy. Federal staff will also provide an update on ATR at an upcoming Committee meeting.

Preliminary work is underway regarding 2012:SR1, *Service Agreements with First Nations & the Regulatory Gap*, through initiatives such as the above reported delegation on Bill S-8, which provided an opportunity to express concerns regarding the regulatory gap that exposes local governments to environmental and public health liabilities related to servicing agreements with First Nations. The intergovernmental staff working group that the Committee is pursuing with MARR would also allow for discussion with senior government on this and other issues that require multi-party attention.

The Committee is also in the early stages of follow-up on resolution 2012: B32, Strategic Engagement Agreements. In its response to the resolution, MARR indicated openness in considering opportunities for potential local government participation in the SEA process on a pilot basis. This has led to preliminary discussion at a staff level, to be investigated further in the coming months.


First Nations Relations Funding Programs:

Regional Community to Community Forum Program

UBCM continues to administer the Regional C2C program, with the Committee providing oversight of the program. Up to 2011/12, the C2C program has been supported by equal contributions of \$50,000 by provincial and federal governments. AANDC staff recently informed UBCM that the 2012/13 fiscal year funding request had been approved, however with substantial restrictions on the transfer and use of program dollars. Under the proposed changes, the federal department could fund First Nations directly, but local governments would not be eligible recipients. It is unlikely the UBCM could continue to provide administrative services to a grant program for which our membership is not eligible. UBCM staff is currently continuing to work with both the provincial and federal governments to advocate for program continuation.

Supporting Treaty Implementation: The STIPP program provides operational funding for TACs/ local governments involved in treaty negotiations.

COMMUNITY SAFETY: FOCUS ON CONSULTATION

RCMP policing costs have continued to be a major issue for the Community Safety Committee over the past year. The Committee has been challenged by the ongoing uncertainty around policing costs. First there were the changes in Federal severance policy which allowed RCMP officers to take a one time pay out for accumulated severance benefits. Secondly, there was the release of a report indicating that the RCMP pension plan was under funded and local government pension costs would increase to 20.23% in 2014. As well, the lack of clarity on how the costs of the new RCMP headquarters in Surrey will be allocated amongst RCMP policed communities has added further to the uncertainty around this matter. It is anticipated that the uncertainty will be reduced moving forward and that the impact of the cost increases will be reduced as a result of cost savings in the delivery of health care and administrative services.

In the past year, the Committee was consulted on the development of a traffic safety plan, changes in the justice system, the development of a plan for the delivery of police services and participated in a cannabis priority setting workshop. The Committee reviewed the development of a province wide road safety strategy and local government participation in the process. It also participated in the first Justice Summit that examined the framework for ongoing consultation around justice issues and it provided input on the development of a policing plan for the province.

The Committee met with the Assistant Deputy Minister, Emergency Management BC, Ministry of Justice to discuss changes in the delivery of fire services and to discuss the delivery of emergency services. The Committee also met with the Executive Director, Building and Safety Standards Branch to follow-up on the policy paper "Modernizing Building Code Safety Regulations" that had been endorsed at the 2012 UBCM Convention and to receive an overview of changes to the BC Building Code that were introduced in 2012. Several meetings were held with provincial and local government representatives to discuss changes in the delivery of RCMP services and the rising costs of these services.

Finally, a number of legislative measures were reviewed by the Community Safety Committee over the past year and input was provided to the Federal and Provincial government. The Committee reviewed the new Health Canada regulations regarding medical marijuana and forwarded comments re-iterating the need to inform local governments about proposals for commercially operated medical marijuana and to ensure that they complied with local government bylaws before receiving federal approval. The Committee also reviewed and commented on a number of regulatory changes to liquor policy that were implemented by the Province. In addition, it provided feedback on the Community Safety Act that was passed by the Provincial Legislature.

After extensive provincial and federal outreach, the Community Economic Development (CED) Committee was successful in ensuring that local government interests would be represented in the development of Integrated Management of Aquaculture Plans for BC. In fact, the Department of Fisheries and Oceans (DFO) responded positively to our request for increased representation on the Aquaculture Management Advisory Committees (AMACs) from one appointment, to four, to ensure that both geographic and sector interests could be adequately represented. Thanks to the following elected officials who have agreed to serve on these AMACs:

- Director Jim Abram, Strathcona RD, AVICC (finfish)

- Director Bill Veenhof, Nanaimo RD, AVICC (shellfish)

- Councillor Bruce Bidgood, Terrace NCLGA (finfish)

- Director Des Nobels, Skeena Queen Charlotte RD, NCLGA (shellfish)

Also on the fisheries front, the Committee identified federal Bill C-38 as one of its priorities. CED members wanted to determine where there were opportunities for local government input into Bill C-38's regulatory process. In March 2013, Chair Pernarowski and Chair Martin (Environment Committee), hosted an engagement session with DFO officials and interested local governments to learn more about the legislative amendments, operational changes and forthcoming regulatory changes.

Fisheries Act amendments reflect a new focus on protecting recreational, commercial and Aboriginal fisheries and identifying and managing threats to fisheries, including habitat destruction and aquatic invasive species. Operationally, the changes are significant: a 30% staff reduction at DFO; \$33 million cut in its operations budget; reduction in service delivery areas from 10 to 5; re-organization by industry sector instead of by area; and DFO is no longer serving as the key organization in the environmental assessment process. UBCM disseminated information about the legislative amendments and operational changes in an effort to seek member feedback so the CED Committee can develop a


coordinated response to DFO from local governments.

In May 2012, the Legislature's Special Committee on Timber Supply was established to investigate and provide recommendations with respect to mid-term timber supply resulting from the pine beetle epidemic and associated timber loss. In July 2012, the Committee prepared a submission identifying key member policy positions of interest to the Special Committee including: seeking greater investment in rehabilitation and reforestation efforts; respecting existing local land use plans and decisions; pursuing economic diversification opportunities; and ensuring community consultation and engagement around resource allocation decisions. The Special Committee reported out and many recommendations are in line with UBCM member policy. The CED Committee will continue to monitor the Province's implementation.

On the broader economic development front, the Committee received delegations from University of Northern BC's Community Development Institute and the Ministry of Jobs, Tourism and Skills Training. In regard to the latter, the Committee provided input into the development of the *Business Attraction Toolkit for BC Communities*. This online toolkit provides resources to assist communities in their business attraction and economic development efforts.

The Committee would like to thank the following individuals who serve on Committees that support its policy work: Councillor Sav Dhaliwal, Burnaby who serves as UBCM's appointment to the BC Hydro Advisory Committee and Mayor John Dooley, Nelson, our appointment to Fortis BC's Resource Planning Advisory Group. Chair Art Kaehn, CED Committee member and EA Rep on the UBCM Executive also serves as UBCM's rep to the Off Road Vehicle (ORV) Joint Advisory Group and chairs the local government working group. The ORV initiative has been identified as one of the key priorities for the Province.

And finally, the Committee continues to monitor other files related to energy, (i.e. oil and gas, pipeline development, mining, electricity, energy conservation) forestry, agriculture and other natural resource/economic development matters.

Building Healthy Communities

Over the past year, the Healthy Communities Committee has monitored and advised on a number of healthy community related issues with health authorities, the Province, and other organizations.

Child poverty has been on the Committee's advocacy agenda since 2009. In 2012, seven communities were chosen to take part in the Regional Community Poverty Reduction pilot project, which appointed poverty strategy consultants to each of the seven communities. These consultants coordinated and led the development of action plans to address the needs of families living in poverty. A forum was held in February 2013 to review the challenges and successes of the pilot project to date. Ministry staff are considering this information prior to the expansion of the project to additional communities.

The Healthy Families BC Communities initiative continues to be a major project of the Committee. This initiative supports local governments in prioritizing health actions in areas such as physical activity, healthy eating, tobacco use, healthy built environments and priority populations to reduce chronic disease and promote healthy weights. The Committee has provided feedback to the provincial government on the proposed learning and leadership network, which will develop tools to support local governments in learning, developing partnerships and taking actions that will increase the health and well-being of BC citizens and communities. Local government action guides have also been developed; as well as a Capacity Building Fund, which provides small grants to local governments for building relationships and partnerships for healthy communities.

The Committee also provided feedback on the Ministry of Health's Guiding Framework for Public Health (formerly known as the Public Health Plan), which aims to improve the health of

British Columbians by creating a long-term vision for the public health system. UBCM offered comments on the role of local governments in public health and in response to these concerns, the Ministry assured UBCM that the plan does not prescribe or transfer responsibilities to local governments, and that local governments would be engaged if any provincial plans or projects in the Guiding Framework affect local governments. Feedback was also provided on 2013/2014 public health priorities. UBCM suggested changes to legislation to support tobacco free environments, and legislation to support drinking water in BC.

Chair Al Richmond, continues to co-chair the Emergency Medical Assistants Emergency Fund Advisory Committee which aims to increase the number of Primary Care Paramedics in rural areas, and Advanced Care Paramedics in BC through the provision of student bursaries. This \$8 million fund was established by the Emergency and Health Services Commission and the provincial government. The Advisory Committee oversees the distribution of education bursaries for emergency medical assistants enrolled in the Advanced Care Paramedic (ACP) and the Primary Care Paramedic (PCP) programs in BC.

Additional Committee work has included:

- Engaging in advocacy activities as a member of the BC Healthy Living Alliance
- Participating as a member on the Provincial Health Services Authority's Healthy Built Environment Alliance, which brings together public health, design and land use professionals to better understand the impact of the built environment on health and well being.
- Became a member of the BC Physical Activity Leadership Table which is working to develop of a physical activity strategy and action plan for the province of BC.

LOCAL GOVERNMENT PROGRAM SERVICES

...programs to address provincial-local government shared priorities



UBCM has delivered numerous provincially funded programs since 2004. Although no new programs were offered in the past year, many funding opportunities were available to local governments, First Nations and other eligible applicants through a number of existing programs.

This year's financial statements include audited accounts for the funds received, amounts disbursed and fund balances. It is important to note that LGPS funds are completely separate from regular UBCM accounts.

The following is a summary of programs administered by LGPS on behalf of the province in the past year.

Community Structural Protection Units

Administered for the Office of the Fire Commissioner/Ministry of Forests, Lands & Natural Resource Operations (\$1 million in 2004, with annual cost recovery)

Structural protection units are available for deployment in the event of a fire in the wildland urban interface. These units are owned by UBCM and managed in cooperation with the Office of the Fire Commissioner and the Ministry of Forests, Lands & Natural Resource Operations. The units were used minimally in 2012, with only 10 deployments.

Regional Community to Community (C2C) Forum Program

Administered for the Ministry of Community, Sport & Cultural Development and Aboriginal Affairs & Northern Development Canada (\$1,207,500 since 1999)

The Regional C2C program has provided opportunities for local governments and First Nations to come together in dialogue on topics of

mutual interest or concern since 1999. To date, more than 400 C2C events have been held across the province.

School Community Connections

Administered with the BC School Trustees Association for the Ministry of Education (\$10 million in 2005)

The School Community Connections (SCC) program was launched in 2005 to promote sustainable and innovative collaboration between boards of education and local governments. To date:

- 55 Boards of Education were funded in at least one phase of the original 2005 program;
- 184 projects were completed under the 2008 program;
- 157 projects have been completed under Rounds 1 & 2 of the 2010 program;
- 20 projects have been completed through the 2012 program, and 26 projects are in progress.

Seniors' Housing & Support Initiative

Administered for the Ministry of Community, Sport & Cultural Development and Ministry of Health (\$3,924,275 since 2004)

The seniors' program was launched in 2004 to assist local governments to prepare for an aging population by supporting the ability of BC's older adults to age in place. Since then, 4 program streams have been supported and, to date:

- 48 local governments were funded to hold dialogue events;
- 52 pilot projects were completed;
- 28 age-friendly planning initiatives were completed under the 2008 and 2009 program;
- 25 age-friendly planning initiatives or community projects were completed under the 2010 program;
- 45 age-friendly planning initiatives

or community projects were completed under the 2012 program, and 7 projects are in progress;

- 27 age-friendly planning initiatives or community projects were funded under the 2013 program and will be completed in early 2014.

Strategic Wildfire Prevention Initiative

Administered for the Ministry of Forests, Lands & Natural Resource Operations (\$62 million since 2004)

The Strategic Wildfire Prevention program has four separate funding streams:

- Community wildfire protection plans (CWPP)
- Pilot projects/Fuel management demonstration projects
- Fuel Management Prescriptions
- Operational fuel treatments.

Since 2004, for both local government and First Nation applicants combined (as of March 31, 2013):

- 252 CWPPs have been developed and 50 are in development;
- 328 fuel management prescriptions have been completed and 64 are in development;
- 193.4 hectares have been treated through pilot/demonstration projects and 1.9 ha have been approved for treatment;
- 5,513.8 ha have been treated through operational fuel treatments and 3,592.9 ha have been approved for treatment.

Supporting Treaty Implementation Pilot Project Program

Administered for the Ministry of Aboriginal Relations & Reconciliation (\$100,000 in 2007)

Initially, the Supporting Treaty Implementation program provided grants for pilot projects that supported treaty implementation through activities such as developing an agreement between a local government and First Nation, establishing a mentoring program, or undertaking a community education campaign. Four projects were completed under the original program.

In 2009, UBCM worked with the Ministry to enhance the program in order to support Treaty Advisory Committees (TACs) to participate at treaty tables. This resulted in a program that provided the opportunity for TACs and/or local governments to apply for operating funds for since 2009/10:

- 8 TACS/local governments received funding for 14 treaty tables in 2009/10;
- 8 TACS/local governments received funding for 12 treaty tables in 2010/11;
- 7 TACS/local governments received funding for 11 treaty tables in 2011/12;
- 6 TACS/local governments received funding for 11 treaty tables in 2012/13;
- 6 TACS/local governments were approved for funding for 11 treaty tables in 2013/14;

The total federal contribution to BC communities through the Gas Tax Fund reached \$1.39 billion in 2013, the eighth year of the program. UBCM administers the funding and provides it to local governments for investments in sustainable infrastructure and capacity building projects across British Columbia.

Gas Tax Agreement programs 2013

General Strategic Priorities Fund and Innovations Fund

With the 2012 General Strategic Priorities Fund (GSPF) and Innovations Fund (IF) application intake closing just prior to UBCM's 2011/12 year-end, one of our highest priorities in the early months of our 2012/13 fiscal year was an evaluation of those applications to prepare for Management Committee approvals. In total, 53 projects, with grant funding of over \$52 million, were approved from that application intake. Announcements for the approved projects took place from January through to April of 2013.

These approvals represent a full commitment of all available GSPF and IF program funds through to the 2015 expiry of the current Gas Tax Agreement. In total, 182 projects were approved for funding of just over \$256 million since the program's inception in 2005. Funding was directed towards innovative projects, such as Nanaimo Regional District's aquifer storage reservoir, as well as projects that were of such magnitude that they would have been difficult for communities to manage with per capita funding, such as a \$10.5 million contribution to North Okanagan's Duteau Creek Water Treatment facility.

Regionally Significant Projects Fund (RSP)

The RSP fund represents dedicated funding for regional and sub-regional projects within Tier 2 regions (Capital, Cowichan Valley, Nanaimo, Squamish-Lillooet, Fraser Valley, Central Okanagan, North Okanagan, and Okanagan-Similkameen regional districts and their member municipalities). In total, the RSP program will provide about \$101.6 million to these regions to support these priorities.

The vast majority of the RSP funding has been committed, with the remaining funds expected to be committed this summer. To date, funding has been committed to all eligible project categories, including:

- Public transit in Capital, Squamish-Lillooet and Central Okanagan;
- Road and bridge in Capital Regional District;
- Active transportation in Squamish-Lillooet, Capital, Cowichan Valley and Central Okanagan;
- Water and wastewater projects in Nanaimo, Fraser Valley, Okanagan-Similkameen, Squamish-Lillooet and Central Okanagan;
- Solid waste, recycling and composting in Cowichan Valley, North Okanagan, and Fraser Valley;
- Energy retrofits in Cowichan Valley, Okanagan-Similkameen, and Central Okanagan; and
- Capacity building activities, in each of the regions, including contributions towards Regional Growth Strategies, sustainability strategies, and to air quality, water monitoring, solid waste management and transportation planning.

Community Works Fund (CWF)

Allocated funding under the CWF program is distributed to all local governments, outside of the Metro Vancouver region, twice a year. Total funding delivered under this program to date is about \$408 million. Decisions about which eligible projects to fund are made locally, and local governments annually report on their Gas Tax spending and the projects funded.

To date, CWF funds have contributed to over 1,600 infrastructure and capacity building projects in BC. While CWF funds have contributed to projects in all eligible project categories, water and wastewater projects top the list, representing about 29% of projects reported.

Tier 3 Strategic Priorities Fund

Allocated funding within the Metro Vancouver region is pooled into the Tier 3 Strategic Priorities Fund, and made available to TransLink for public transit investments. This arrangement is in keeping with a 2005 Metro Vancouver Regional District resolution, and to date about \$677 million in funding has been provided for these purposes.

Investments to date include: bus fleet expansions and replacements; SkyTrain improvements, such as SkyTrain cars, the Expo Line propulsion upgrades,

and an operations and maintenance centre; and contributions towards a third SeaBus.

Outreach, Communications and Reporting

Over the past year, Gas Tax Management Services has continued its practice of providing direct support and advice to local governments on the eligible use of funds. We have also dramatically expanded the amount of information available on the use of funds by community on our website. With the large number of projects now complete or underway, it is now easier to see the contribution the program is making to BC communities.

In addition, UBCM produces an Annual Expenditure Report each September that reports on Gas Tax activities for the previous year. That report provides UBCM and recipient financial information, as well as program details and highlights of projects funded.

Notes to Financial Statements

Years ended June 30, 2013 and 2012

1. Operations:

The Union of British Columbia Municipalities ("UBCM") is incorporated under the Union of British Columbia Municipalities Act and its principal activity is to represent the interests of its members in dealing with other orders of government. The UBCM is a not-for-profit organization and is exempt from income and capital taxes.

The UBCM's operations include the following significant activities:

- (i) Operating - Reflects the general operating activities and administration functions of the UBCM.
- (ii) Special projects - Administers special services provided to members and to account for the revenue and expenses directly related to the annual convention.
- (iii) Local Government Program Services - The Province of British Columbia has provided funding to the UBCM for shared provincial-local government interests in a variety of fields. The service that the UBCM provides is to control and deliver those funds to members for the purposes of the various programs.
- (iv) Gas Tax - The Government of Canada and the Province of British Columbia have entered into agreements with the UBCM under the Agreement on the Transfer of Federal Gas Tax Revenues under the New Deal for Cities and Communities 2005 – 2015 (the "Gas Tax Agreement") to transfer funding to the UBCM to control and deliver the funding to local government organizations in British Columbia. The purpose of the funding is focused on achieving environmental sustainability and the improvement of public transit and infrastructure.

On July 1, 2012, UBCM adopted Canadian accounting standards for not-for-profit organizations in Part III of the CICA Handbook. These are the first financial statements prepared in accordance with Canadian accounting standards for not-for-profit organizations.

In accordance with the transitional provisions in Canadian accounting standards for not-for-profit organizations, UBCM has adopted the changes retrospectively, subject to certain exemptions allowed under these standards. The transition date is July 1, 2011 and all comparative information provided has been presented by applying Canadian accounting standards for not-for-profit organizations.

The UBCM has made no transitional elections as at the transition date of July 1, 2011 on the first time adoption of Canadian accounting standards for not-for-profit organizations. There were no transitional adjustments to net assets as at July 1, 2011 or excess of revenue over expenses and cash flows from operating activities for the year ended June 30, 2012 as a result of the transition to Canadian accounting standards for not-for-profit organizations.

2. Significant accounting policies:

The financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations in Part III of the CICA Handbook. Significant accounting policies include:

(a) Revenue recognition:

The UBCM follows the deferral method of accounting for contributions which include government grants. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Externally restricted contributions are recorded as deferred revenue and contributions in the year received, and recognized as revenue in the year in which the related expenses are recognized.

Unrestricted investment income is recognized as revenue when earned. Restricted investment income is recorded as deferred revenue and contributions in the year received, and recognized as revenue in the year in which the related expenses are recognized.

Contributed capital assets are measured at the fair value at the date of contribution. Contributed capital assets not subject to amortization, such as land, are recorded as direct increases in net assets in the period the assets are received. Contributed capital assets subject to amortization and contributions restricted for the purchase of capital assets are deferred and amortized into revenue on a straight line basis, at a rate corresponding with the amortization rate for the related capital assets.

Revenue from annual dues, special levies, fees and contracts is recognized when the services are provided. Amounts collected relating to subsequent periods are recorded as deferred revenue and contributions.

(b) Capital assets:

Capital assets are recorded at cost less accumulated amortization. Amortization is provided on a straight-line basis over the assets' estimated useful lives as follows:

2. Significant accounting policies (continued):

(c) Financial instruments:

Financial instruments are recorded at fair value on initial recognition. Freestanding derivative instruments that are not in a qualifying hedging relationship and equity instruments that are quoted in an active market are subsequently measured at fair value. All other financial instruments are subsequently recorded at cost or amortized cost, unless management has elected to carry the instruments at fair value. The UBCM has elected to carry its investments at fair value.

Transaction costs incurred on the acquisition of financial instruments measured subsequently at fair value are expensed as incurred. All other financial instruments are adjusted by transaction costs incurred on acquisition and financing costs, which are amortized using the straight-line method.

Financial assets are assessed for impairment on an annual basis at the end of the fiscal year if there are indicators of impairment. If there is an indicator of impairment, the UBCM determines if there is a significant adverse change in the expected amount or timing of future cash flows from the financial asset. If there is a significant adverse change in the expected cash flows, the carrying value of the financial asset is reduced to the highest of the present value of the expected cash flows, the amount that could be realized from selling the financial asset or the amount the UBCM expects to realize by exercising its right to any collateral. If events and circumstances reverse in a future period, an impairment loss will be reversed to the extent of the improvement, not exceeding the initial carrying value.

(d) Use of estimates:

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

3. Investments:

Investments are comprised of pooled investments with Municipal Finance Authority in money market funds with an average annualized yield of 1.09% for the year ended June 30, 2013.

10. Trust funds:

The UBCM administers the following trust funds where activities and balances are not reflected in the UBCM's financial statements:

(a) Jeff McKelvey scholarship fund:

The Jeff McKelvey scholarship fund was established through contributions from members, the Province of British Columbia and other individuals. Scholarship applications and awards are made within the Union executive's general guidelines by the Board of Examiners.

(b) UBCM / Federation of Canadian Municipalities ("FCM") travel fund:

The UBCM administers the UBCM / FCM travel fund. The purpose of the fund is to assist FCM board members with their travel costs to FCM meetings through per capita levies.

(c) Commercial vehicle license program fund:

Participating municipalities remit license fees collected for commercial vehicles to the UBCM in trust. Surplus funds are distributed to the participating municipalities on December 31 annually.

11. Commitment:

The UBCM has an operating lease for its office space in Richmond, British Columbia, which expires on June 30, 2017. The annual basic lease payment plus the estimated proportionate share of taxes and operating expenses is \$109,206.

12. Contingent pension liability:

The UBCM and its employees contribute to the Municipal Pension Plan (the "Plan"), a jointly trustee pension plan. The board of trustees, representing plan members and employers, is responsible for overseeing the management of the Plan, including the investment of the assets and administration of benefits. The Plan is a defined benefit multi-employer contributory pension plan. The Plan has about 176,000 active members and approximately 63,000 retired members. Active members include approximately 35,000 contributors from local governments.

The most recent valuation as at December 31, 2009 indicated a \$1,024 million funding deficit for basic pension benefits. The next valuation will be as at December 31, 2012 with results available in 2013. Defined contribution plan accounting is applied to the Plan as the Plan exposes the participating entities to actuarial risks associated with the current and former employees of other entities with the results that there is no consistent and reliable basis for allocating the obligation, Plan assets and costs to individual entities participating in the Plan. During the year, the UBCM expensed \$134,312 (2012 - \$131,811) of payments to the Plan.

13. Financial risks:

(a) Credit risk:

Credit risk refers to the risk that a counterparty may default on its contractual obligations resulting in a financial loss. For cash and cash equivalents, restricted cash and cash equivalents and accounts receivable, the UBCM's credit risk is limited to the carrying value on the statement of financial position. Management does not believe that the UBCM is subject to any significant concentration of credit risk.

(b) Liquidity risk:

Liquidity risk is the risk that the UBCM will be unable to fulfill its obligations on a timely basis or at a reasonable cost. The UBCM manages liquidity risk by maintaining adequate cash and cash equivalents available. The UBCM monitors the cash flow to ensure a sufficient continuity of funding.

(c) Interest rate risk:

The UBCM is not exposed to significant interest risk as it does not have amounts payable that are charged interest.
