Letter of Transmittal to UBCM Members

It is our pleasure to deliver the 2014 Union of BC Municipalities Annual Report to our membership. We have dedicated extensive resources to redesign the layout of this report and hope you find it informative.

UBCM was created by BC local governments over a century ago to provide a unified voice for communities. Once again this year, 100% of BC's local governments and several First Nations have renewed their membership. The commitment of our membership is a measure of UBCM's effectiveness in fulfilling its purpose. As we look forward to a new year of advocacy and program delivery, we will continue to hold to the principles that have proven effective over many years by advancing policy based, member-determined positions combined with a collaborative, non-partisan approach.

The 2014 report includes a number of milestones for BC local governments. The launch of the renewed Gas Tax Fund is the result of several years of work to identify the current needs of BC communities with respect to infrastructure funding and negotiating changes in the design of the program to better serve those needs. We remain appreciative of the constructive approach taken by the federal and provincial governments throughout the negotiations. The feedback from local governments since the launch of the renewed Gas Tax Fund tells us that the program is on track for the next decade.

Of course funding programs are only part of the story when it comes to financing local government. At the 2013 Convention, members unanimously endorsed the Strong Fiscal Futures policy paper that set out a framework to renew the system for local government finance. Over the past year we have engaged with the Province to seek agreement on a joint process to undertake a comprehensive review of the finance system and this objective was the focus of our Advocacy Day meetings with Ministers and MLAs from all parties back in April. We will continue to seek a provincial commitment to a joint process in the days leading into the 2014 Convention and look forward to providing a full update in the President's Address.

More recently, we have worked with AVICC to research the financial impact of cuts and increased fares to BC Ferries recognizing that these changes will impact both coastal and non-coastal communities. This report is the key policy paper coming forward to the 2014 Convention, and addresses a significant information gap in the public debate and decision making related to ferries policy. We encourage you to join us for the policy session Tuesday afternoon at Convention where the policy paper will be discussed.

These items, while significant, form only a part of our work on behalf of the membership over the past year, however; the following Annual Report delves into more depth in all areas of our work.

It has been an honour to serve local government, and by extension, the people of British Columbia over this past year.

Executive Priorities

At the first meeting of the UBCM Executive in November 2013, board members identified their priorities for the coming year. The chart below provides an overview of the identified priorities and their status at year-end.

As well, the following page provides greater detail on the work undertaken to advance these priorities.

Local Government Elections Legislation	Bill 20, Local Elections Campaign Financing Act; and Bill 21 Local Elections Statute Amendment Act enacted to implement changes for November 2014 local elections; work continues on phase 2, election expense limits.
Local Government Finance Advocacy	Strong Fiscal Futures (SFF) report adopted at 2013 Convention; Select Finance Committee re-established; SFF report conveyed to Province; extensive advocacy campaign undertaken at April Executive meeting to promote SFF report with provincial government.
Gas Tax/Building Canada Renewal	Renewed Gas Tax Program announced in May 2014; and the new Building Canada Fund announced in March 2014.

Recycling Stewardship Program – Multi-Materials BC (MMBC)	Significant staff and Executive resources dedicated to represent member interests in response to the MMBC's recycling stewardship proposal this past year.

Gas Tax Renewal

The federal government, the provincial government and UBCM signed a renewed gas tax agreement at the end of May 2014. The agreement will provide \$1.3 billion over the next five years through three program streams, and an estimated \$2.7 billion over ten years in infrastructure funding. The renewed agreement is the result of several years of advocacy and negotiation by UBCM and the Federation of Canadian Municipalities. UBCM's negotiating mandate was informed by both local government feedback during the federal government's consultations on the Long-Term Infrastructure Plan in 2012, as well as direct member consultations, and a UBCM survey of the membership's experiences with the first nine years of the gas tax program. UBCM believes the outcomes of the renewed gas tax agreement reflect key local government positions, as there are: broader project categories, in such areas as recreation and cultural infrastructure; annually indexed funding at 2%; greater local decision-making; and a retained mix of allocated and pooled funds.

Strong Fiscal Futures – Advocacy

At the 2013 Convention, the UBCM membership unanimously endorsed the report of the Select Local Government Finance Committee called Strong Fiscal Futures – A Blueprint for Strengthening Local Government Finance System. UBCM has sought to engage the Province on this key initiative of the membership throughout the year. In April, the UBCM Executive worked to build awareness of, and support for, the report through two days of advocacy meetings with MLAs. Executive members met with twenty-nine elected officials, including nine ministers and opposition party leaders, where they asked for the creation of a joint provincial management committee as the first step in advancing the recommendations of Strong Fiscal Futures. Discussions have taken place between UBCM staff and senior Ministry of Community, Sport and Cultural Development (MCSCD) staff on the management committee proposal, and UBCM President Rhona Martin has conveyed the importance of moving forward with the report in a meeting with Minister Coralee Oakes.

MMBC

In October 2013, UBCM struck the UBCM Recycling Negotiating Committee in response to Resolution SR1-2013 and member concerns over the design and implementation of Multi-Materials BC's packaging and printed paper (PPP) product stewardship program. Throughout the Fall, the Committee identified key issues and positions, conducted a legal review, and surveyed the membership. The Committee met with the Minister of Environment, senior MMBC staff, and legal counsel, and raised concerns over MMBC's contract structure, industry's implementation timelines, and MMBC's approach to negotiating with local government. In recognition of the state of negotiations between MMBC and local governments, the Committee provided clarifying information on MMBC's contract and program structure in advance of industry's deadline for executing agreements. Local government representatives have also been appointed to MMBC's Advisory Committee to provide feedback on core elements of the program.

The Executive continues to monitor the implementation of the PPP program, and recently had delegations from MMBC and MOE at its July Executive meeting.

Corporate Operations

Local Government Elections Legislation

In May 2010, the Report of the Local Government Elections Task Force was released identifying recommended changes for improving local government elections. This past March two bills were introduced into the Legislature to implement the recommendations contained within the Task Force's Report.

Bill 20, the Local Elections Campaign Financing Act (LECFA) in conjunction with Bill 21, makes changes to local elections, with the exception of campaign expense limits. The matter of expense limits is still a work in progress; a direction supported by UBCM Executive recognizing the challenges in developing a formula that fits all local governments. LECFA defines various forms of election campaigns and advertising; sets out requirements for campaign accounting; and sets out requirements for third party advertising. In addition, the Act addresses transparency and disclosure requirements, penalties, enforcement, and administrative responsibilities (outlines new role for Elections BC).

Bill 21, Local Elections Statutes Amendment Act, brings forward a number of changes to local elections including: increases the term of office from 3 years to 4 years; moves general voting day to one month earlier than its current date (October, 2018); adds LECFA to the legislation on which the Province must consult with the UBCM before proposing changes; and addresses a number of other administrative matters.

Both Bills received Royal Assent on May 29th.

The Executive continues to work with the Province on the outstanding piece of work related to campaign expense limits.



A top priority for UBCM is to advocate on behalf of BC local governments for the development and implementation of legislation, regulation, policies and programs that support the membership's needs. Our goal is to effect change that will benefit BC local governments. In order to effect change, UBCM participates in policy development and implementation processes in a number of ways:

- proactively presenting our own independent initiatives to other governments (i.e. Strong Fiscal Futures)
- reactively responding to proposed provincial or federal policy changes (i.e. Agriculture Land Commission)
- ongoing involvement participating in Ministry-UBCM or multi-party policy development processes which are many and varied with some requiring sustained involvement while others may only require limited intervention (i.e. Off Road Vehicle Joint Advisory Group).

Much of UBCM's policy work is done through the Executive and its Committees. The following pages provide an overview of the extensive policy work undertaken and outlines progress to date on various issues identified through annual Committee work plans.

Convention Committee

The 2013 Convention was held in Vancouver from September 16-20, and adopted a Navigating the Local Landscape theme. A total of 1,955 delegates attended the Convention, representing 193 UBCM member communities from all across the province. The overall convention rating was 4.3 out of 5, tying 2005 for highest overall convention since UBCM started tracking results electronically in 1997.

A variety of tours and sessions were held this year on topics ranging from building and protecting sustainable communities to local government finance. Programming also included a diverse range of clinics and workshops, including "What does Rural BC Need to Succeed?", "Local Government Elections Reform", and "Canada-European Union Trade Negotiations". As always, delegates had the opportunity to set policy through Resolutions sessions, and participate in a number of Provincial Policy sessions, Cabinet Panels and government meetings.

Resolutions Committee

The resolutions process is the foundation of UBCM's advocacy on behalf of BC local governments.

Members often ask UBCM about the status or progress of the policy development arising from a particular resolution endorsed by the UBCM membership at Convention. Through resolutions, UBCM members speak with one voice to express the needs and concerns of BC communities. Issues raised and solutions proposed in resolutions often result in positive change for the membership.

The Resolutions Committee wishes to highlight examples of the constructive dialogue and successes that we achieve through this process. The following developments have been noted in 2013-2014; each of the issues referenced was the topic of a resolution from a UBCM member local government.

Emerging Policy Files

Agricultural Land Reserve Act Amendments

On May 29, 2014 amendments to the ALR Act now divide the province into two agricultural zones. Zone 1 includes the existing Island, South Coast and Okanagan while Zone 2 will include the existing Interior, Kootenay and North. The mandate in Zone 1 will be similar to the current process with primary focus being on the preservation of agricultural land. The mandate in Zone 2 will be broadened from the preservation of agricultural and social values in the area; regional and community planning objectives and other prescribed considerations.

Two key amendments were introduced and made prior to the passage of the bill. First, the Chair and Executive Committee now have the ability to decide the fate of land deemed to be of provincial importance or that overlaps more than one region. The second amendment was to clarify that even in Zone 2, the primary objective was the protection of agricultural land.

In addition, Section 879 of the *Local Government Act* will be amended to require local government consultation with the Agricultural Land Commission if the development, repealing or amendment of an official community plan might affect agricultural land. The ALC will continue to have the power to make final decisions on specific land uses and the authority to protect agricultural land in both zones.

UBCM will be represented on the Agricultural Land Reserve Consultation Reference Group that is being established to advise on the development of new regulations under the *Agricultural Land Commission Act* to ensure that local government interests are addressed.

Building Code Amendments

On March 27, 2014, UBCM received a letter from Minister Coleman advising of the Province's intention to move forward with measures to implement a modern building regulatory system in 2015. The letter also requested UBCM participation in the Modernization Advisory Group to look at draft legislation to establish a uniform building code across the Province. Such a move would require an amendment to the Community Charter as local government would no longer have the ability to adjust the building regulations to meet local needs; such as ability to determine the type of construction material that can be used to build a house in a wildfire area.

The Executive has directed to become engaged in this file and has approved the establishment of a local government advisory group to assist in the discussions related to potential legislative and policy changes that may be brought forward.

Policy and Advocacy

Ongoing Policy Files

Off Road Vehicle Management Framework

Continued to participate in the development of regulations that will accompany the new *Off Road Vehicle (ORV) Act* such as registration and licensing. UBCM supports the project by participating in the ORV Joint Advisory Group and seeks direction from its own Local Government working group.

Natural Resource Roads Act

Advocated to the Province that local government concerns regarding future access to crown land and the consultation process be addressed while developing a new *Natural Resources Roads Act*.

Derelict Vessels

Established the Problem Vessel Working Group in June 2013, reviewed the "Practical Manual for Addressing Problem Vessels and Structures", and sought input from UBCM members on the manual through a session at the 2013 Convention.

BC Transit Independent Review Working Group

Established BC Transit Independent Review working Group to address how best to implement the Independent Review's recommendations. Extensive work has been undertaken to advance the recommendations and most have been completed or are nearing completion.

Community/Rail Proximity Initiative

Invited BC communities to participate in FCM's Rail Proximity Committee to voice their specific concerns around whistle blowing, crossings, and weed management.

National Municipal Rail Safety Working Group

Supported the work of the National Municipal Rail Safety Working Group established by FCM in response to the Lac Megantic rail accident. UBCM assisted in coordinating feedback from BC communities to assist the advocacy efforts of the National Working Group. Transport Canada has responded by issuing new directives and regulations to address rail safety.

Assessment Appeals: Special Use Properties

Discussed the potential risk and proposed legislative solution with BC Assessment and the Ministry of Community, Sport and Cultural Development staff regarding a reduction in assessment rates on special use properties.

Aggregate Resource Management

Recognized the complex decision-making process regarding aggregate operations and committed to participate in the development of a new strategy for aggregate management.

Care Home Sprinkler Safety

Convened with the Ministry of Health, BC Care Providers Association, BC Fire Chief's Association and other related agencies to identify safety risks of care homes in British Columbia and determine further action.

Federal Additions to Reserve Policy

Prepared a submission on the revised Federal Additions to Reserve Policy in October 2013 based on member feedback, UBCM policy, and internal analysis. On December 3, UBCM was invited to present on behalf of FCM to the House of Commons Standing Committee on Aboriginal Affairs and Northern Development in Ottawa regarding the revised Policy on Additions to Reserve/Reserve creation. The testimony allowed UBCM to convey member concerns contained within UBCM's submission.

Canadian Prostitution Laws

Committed to working with the FCM to monitor the development of federal legislation related to prostitution and assess the impact on any proposed changes on local government.

911 Emergency Services – Wireless Levy

Prepared a report on the feasibility of wireless levies to contribute to the costs of 911 emergency services, tested support for a province wide levy on wireless devices, and concluded that there was not sufficient support to move forward with the initiative at this time.

Farm Assessment – Medical Marijuana Grow Operations

Approached the Province to discuss the issue that local government could lose property tax revenues if medical marijuana grow operations could qualify for farm classification, and confirmed that federally licensed medical marijuana grow operations will be excluded from the list of agricultural uses which qualify for farm classification for assessment and property tax purposes.

Farm Assessment Report

Worked with the Province on the development and implementation of changes to the farm assessment process.

Auditor General for Local Government

Local Government Program Services

UBCM has delivered numerous provincially funded programs since 2004. Many funding opportunities were available to local governments, First Nations and other eligible applicants in 2014.

Community Structural Protection Units

Administered for the Office of the Fire Commissioner/Ministry of Forests, Lands & Natural Resource Operations (\$1 million in 2004, with annual cost recovery), structural protection units are available for deployment in the event of a fire in the wildland urban interface.

Regional Community to Community (C2C) Forum Program

Administered for the Ministry of Community, Sport & Cultural Development and Aboriginal Affairs & Northern Development Canada (\$1,297,500 since 1999). The Regional C2C program provides opportunities for local governments and First Nations to come together in dialogue on topics of mutual interest or concern.

School Community Connections

Administered with the BC School Trustees Association for the Ministry of Education (\$10 million in 2005), the program was launched in 2005 and closed in 2013, the program promoted sustainable and innovative collaboration between boards of education and local governments.

Seniors' Housing & Support Initiative

Administered for the Ministry of Community, Sport & Cultural Development and Ministry of Health (\$4,424,275 since 2004), the program assists local governments to prepare for an aging population by supporting the ability of BC's older adults to age in place.

Strategic Wildfire Prevention Initiative

Administered for the Ministry of Forests, Lands & Natural Resource Operations (\$62 million since 2004), the Strategic Wildfire Prevention program has four funding streams:

- Community wildfire protection plans (CWPP)
- Pilot projects/Fuel management demonstration projects
- Fuel Management Prescriptions
- Operational fuel treatments.

Supporting Treaty Implementation Pilot Project Program

Administered for the Ministry of Aboriginal Relations & Reconciliation (\$600,000 in 2007), this program closed in 2014. The program initially provided grants for pilot projects that supported treaty implementation and supported Treaty Advisory Committees (TACs) to participate at treaty tables.

Gas Tax Agreement Renewal

On May 22, 2014 UBCM, Canada, and BC announced the Administrative Agreement on the Federal Gas Tax Fund in British Columbia (renewed Gas Tax Agreement or GTA).

The GTA provides the administrative frameworks for the delivery of federal Gas Tax funding to British Columbia local governments and other recipients over the next 10 years.

This Agreement replaces the nine year 2005 Gas Tax Agreement which delivered over \$1.6 billion in federal funding for local government infrastructure and capacity building projects in British Columbia.

UBCM continues administers the Gas Tax fund on behalf of the parties and delivers three funding programs through the fund.

Community Works Fund

- UBCM will deliver over \$95 million to all local governments in 2014 through the Community Works Fund program
- In 2014, the Community Works Fund program has an expanded eligible investment category list to now include the following local government capital infrastructure: local roads and bridges; highways; short-sea shipping; short-line rail; regional and local airports; broadband connectivity; public transit; drinking water; wastewater; solid waste; community energy systems; brownfield redevelopment; sport infrastructure; recreational infrastructure; cultural infrastructure; tourism infrastructure; and disaster mitigation.
- Local Governments will continue to be able to use the CWF towards capacity building projects under the new program, including development of asset management planning.
- Local Governments CWF allocation is based on a funding floor of \$50,000 and a per capita amount.

Strategic Priorities Fund

- It is expected that the Strategic Priorities Fund program (SPF) will be launched in 2014.
- The SPF is an application based Gas Tax program, which is available for local governments outside of the Greater Vancouver region.
- The SPF program will provide funding for eligible projects that are larger in scale or regional in impact or innovative.

Greater Vancouver Regional Fund

- UBCM continues to deliver pooled funding in the Greater Vancouver region for regional transportation projects.
- The Greater Vancouver Regional Fund replaces the Strategic Priorities Fund for Greater Vancouver.

UBCM coordinates distribution of licence decals to program members, who must make them available for sale to owners and operators of commercial vehicles using municipal roads in a participating municipality.

There were 100 participating local government members, which sold over 39,000 licences resulting in over \$930,000 shared by the program members this year.

Independent Auditors' Report

To the Members of the Union of British Columbia Municipalities

Notes to Financial Statements

11 month period ended May 31, 2014, with comparative information for the year ended June 30, 2013.

1. Operations:

The Union of British Columbia Municipalities ("UBCM") is incorporated under the Union of British Columbia Municipalities Act and its principal activity is to represent the interests of its members in dealing with other orders of government. The UBCM is a not-for-profit organization and is exempt from income and capital taxes.

During fiscal 2014, the UBCM changed its year end from June 30 to May 31. As such, these financial statements are prepared as at and for the 11 month period ended May 31, 2014. The comparative figures are as at and for the year ended June 30, 2013.

The UBCM's operations include the following significant activities:

- (i) Operating Reflects the general operating activities and administration functions of the UBCM.
- (ii) Special projects Administers special services provided to members and activities directly related to the annual convention.
- (iii) Local Government Program Services The Province of British Columbia has provided funding to the UBCM for shared provincial-local government interests in a variety of fields. The service that the UBCM provides is to control and deliver those funds to members for the purposes of the various programs.
- (iv) Gas Tax The Government of Canada and the Province of British Columbia have entered into agreements with the UBCM under the Agreement on the Transfer of Federal Gas Tax Revenues under the New Deal for Cities and Communities 2005 – 2015 (the "Gas Tax Agreement") to transfer funding to the UBCM to control and deliver the funding to local government organizations in British Columbia. The purpose of the funding is focused on achieving environmental sustainability and the improvement of public transit and infrastructure.

The Government of Canada and the Province of British Columbia have entered into a renewed Gas Tax Agreement with UBCM effective April 1, 2014 until March 31, 2024.

2. Significant accounting policies:

The financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations in Part III of the CPA-Canada Handbook. Significant accounting policies include:

(a) Revenue recognition:

The UBCM follows the deferral method of accounting for contributions which include government grants. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Externally restricted contributions are recorded as deferred revenue and contributions in the year received, and recognized as revenue in the year in which the related expenses are recognized.

Unrestricted investment income is recognized as revenue when earned. Restricted investment income is recorded as deferred revenue and contributions in the year received, and recognized as revenue in the year in which the related expenses are recognized.

Contributed capital assets are measured at the fair value at the date of contribution. Contributed capital assets not subject to amortization, such as land, are recorded as direct increases in net assets in the period the assets are received. Contributed capital assets subject to amortization and contributions restricted for the purchase of capital assets are deferred and amortized into revenue on a straight line basis, at a rate corresponding with the amortization rate for the related capital assets.

Revenue from annual dues, special levies, fees and contracts is recognized when the services are provided. Amounts collected relating to subsequent periods are recorded as deferred revenue and contributions.

(b) Capital assets:

Capital assets are recorded at cost less accumulated amortization. Amortization is provided on a straight-line basis over the assets' estimated useful lives as follows:

2. Significant accounting policies (continued):

(c) Financial instruments:

Financial instruments are recorded at fair value on initial recognition. Freestanding derivative instruments that are not in a qualifying hedging relationship and equity instruments that are quoted in an active market are subsequently measured at fair value. All other financial instruments are subsequently recorded at cost or amortized cost, unless management has elected to carry the instruments at fair value. The UBCM has elected to carry its investments at fair value.

Transaction costs incurred on the acquisition of financial instruments measured subsequently at fair value are expensed as incurred. All other financial instruments are adjusted by transaction costs incurred on acquisition and financing costs, which are amortized using the straight-line method.

Financial assets are assessed for impairment on an annual basis at the end of the fiscal year if there are indicators of impairment. If there is an indicator of impairment, the UBCM determines if there is a significant adverse change in the expected amount or timing of future cash flows from the financial asset. If there is a significant adverse change in the expected cash flows, the carrying value of the financial asset is reduced to the highest of the present value of the expected cash flows, the amount that could be realized from selling the financial asset or the amount the UBCM expects to realize by exercising its right to any collateral. If events and circumstances reverse in a future period, an impairment loss will be reversed to the extent of the improvement, not exceeding the initial carrying value.

(d) Use of estimates:

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

3. Investments:

Investments are comprised of pooled investments held with the Municipal Finance Authority in money market funds. For the 11 month period ended May 31, 2014, the average annualized yield is 1.10% (year ended June 30, 2013 – 1.09%).

On November 1, 2012, the BCHC program began operating as the BC Health Communities Society ("BCHC Society") and the UBCM transferred all funds held by the UBCM under the BCHC program to the BCHC Society.

10. Trust funds:

The UBCM administers the following trust funds where activities and balances are not reflected in the UBCM's financial statements:

(a) Jeff McKelvey scholarship fund:

The Jeff McKelvey scholarship fund was established through contributions from members, the Province of British Columbia and other individuals. Scholarship applications and awards are made within the Union executive's general guidelines by the Board of Examiners.

(b) UBCM / Federation of Canadian Municipalities ("FCM") travel fund:

The UBCM administers the UBCM / FCM travel fund. The purpose of the fund is to assist FCM board members with their travel costs to FCM meetings through per capita levies.

(c) Commercial vehicle license program fund:

Participating municipalities remit license fees collected for commercial vehicles to the UBCM in trust. Surplus funds are distributed to the participating municipalities on December 31 annually.

11. Commitment:

The UBCM has an operating lease for its office space in Richmond, British Columbia, which expires on June 30, 2017. The annual basic lease payment plus the estimated proportionate share of taxes and operating expenses is \$109,206.

12. Contingent pension liability:

The UBCM and its employees contribute to the Municipal Pension Plan (the "Plan"), a jointly trusteed pension plan. The board of trustees, representing plan members and employers, is responsible for overseeing the management of the Plan, including the investment of the assets and administration of benefits. The Plan is a defined benefit multi-employer contributory pension plan. The Plan has about 179,000 active members and approximately 71,000 retired members. Active members include approximately 35,000 contributors from local governments.

The most recent valuation as at December 31, 2012 indicated a \$1,370 million funding deficit for basic pension benefits. The next valuation will be as at December 31, 2015 with results available in 2016. Employers participating in the Plan record their pension expense as the amount of employer contributions made during the year (defined contribution pension plan accounting). This is because the Plan records accrued liabilities and accrued assets for the Plan in aggregate with the result that there is no consistent and reliable basis for allocating the obligation, assets and cost to the individual employers participating in the Plan.

During the 11 month period ended May 31, 2014, the UBCM paid \$128,737 (year ended June 30, 2013 - \$134,312) for employer contributions to the Plan.

13. Financial risks:

(a) Credit risk:

Credit risk refers to the risk that a counterparty may default on its contractual obligations resulting in a financial loss. For cash and accounts receivable, the UBCM's credit risk is limited to the carrying value on the statement of financial position. Management does not believe that the UBCM is subject to any significant concentration of credit risk.

(b) Liquidity risk:


Liquidity risk is the risk that the UBCM will be unable to fulfill its obligations on a timely basis or at a reasonable cost. The UBCM manages liquidity risk by maintaining adequate cash. The UBCM monitors the cash flow to ensure a sufficient continuity of funding.

(c) Interest rate risk:

The UBCM is not exposed to significant interest risk as it does not have amounts payable that are charged interest.

14. Comparative information:

Certain comparative information have been reclassified to conform with the financial statement presentation adopted for the current year.
