Letter of Transmittal to UBCM Members

As the President and Executive Director of UBCM we are pleased to convey the 2008 Annual Report.

In the past year three new municipalities were incorporated in British Columbia, a sign of the continued growth of our Province. We are pleased to welcome Westside, Barriere and Clearwater into our membership. This reflects the 29th consecutive year that UBCM has represented 100 percent of the local governments in B.C.

Local governments in British Columbia are best served through a common voice. Our challenge is to continue to ensure that UBCM is able to respond to the diverse needs of our membership and to build consensus. The activities of 2008 and the results outlined in this Annual Report are proof of UBCM's continued efforts to advocate and support all elements of our diverse membership.

In 2008 we played an active role in the signing of a one billion dollar funding extension to the Gas Tax Agreement for the years 2011 – 2014. We were also involved in negotiations, which led to the signing of a Communities Component Agreement under Building Canada. We were the first province in Canada to achieve these two milestones. In addition, UBCM successfully advocated that funding be set aside from the Building Canada Fund for those larger municipalities who were not eligible under the Communities Component.

Governments continued to show support for efforts to reduce greenhouse gas emissions in British Columbia. Resolutions of support for the Climate Action Charter continued to pour in and UBCM has worked to advance the local government commitments that are defined in the Charter.

This year also saw extensive time and resources committed to negotiating amendments to TILMA on behalf of the membership. Work was also initiated on two other long-term projects involving a targeted review of regional district issues and local government financing.

The Annual Report also describes an active year for our provincially funded grant programs. Phase One of the Community Tourism funding was completed and Phase Two is well underway. New programs were rolled out in the areas of Built Environment and Active Transportation, Building First Nations Governance Capacity and Support Treaty Implementation.

On an operational level, our focus this year was on achieving a smooth transition in the Executive Director position. It is crucial that we continue to look at the future needs of our membership while keeping in mind the strategies and partnerships that have brought us our past successes. To this end, we would like to thank Richard Taylor for his advice and contributions over the past year.

We encourage you to read the detailed accomplishments set out in this Annual Report.

ADVOCACY

Policy Development and Implementation

A top priority is to advocate on behalf of BC local governments for the development of policies that support their needs and to see them implemented in legislation, regulations, programs or policies. UBCM participates in policy development in a number of ways: independent initiatives and making representations directly; participating in Ministry– UBCM or multi-party policy development processes. The issues are many and varied and some have required sustained involvement while others may have only required limited intervention.

Member Initiatives: Resolutions

UBCM's policy initiatives are primarily derived from resolutions submitted by members. During 2008, UBCM reviewed many high quality, clearly written and well-researched resolutions in the course of preparing the Annual Report and Resolutions Book. All Area Associations submitted their resolutions for UBCM comment prior to their annual meetings and subsequently conveyed endorsed resolutions to UBCM for consideration at the 2008 Convention.

REGULATIONS (IN ORDER OF DEGREE OF UBCM INVOLVEMENT)

UBCM contributed to the development of many regulations including:

- wildfire regulation (amendment)
- subdivision regulation
- landfill gas capture regulation
- riparian areas regulation
- smoking regulation
- zero emission vehicles

UBCM Resolutions Responses

A total of 175 resolutions were forwarded to the provincial government for consideration following the 2007 UBCM Convention. In addition, 33 resolutions were conveyed to the federal government and four were conveyed to the FCM. Responses have been conveyed to the resolution sponsors.

The Province has indicated that 67 issues raised in the 2007 resolutions have already been addressed

in whole or in part by provincial initiatives and noted that it was not willing to consider changes proposed in 37 of the resolutions. Provincial support was noted in the case of six resolutions and the Province indicated it is willing to consider the changes/suggestions/concerns expressed in 13 other resolutions. Further review and/or action will be undertaken on the changes suggested in an additional 18 resolutions. As well, UBCM is already working with the Province on four resolutions and will monitor provincial action in several other policy areas.

UBCM Program Management and Administration

Health Programs

- Community Health Promotion Fund 42 pilot projects approved for Round 3. A total of 121 projects have now received approval
- Seniors' Housing & Support Initiative 21 pilot projects were approved for Round 3; resulting in 52 projects in 40 communities funded to date. In 2007, 7 'Seniors in Communities' dialogues were funded and 5 have been funded to date in 2008. In total close to 40 dialogues have now been approved
- Healthy Food & Beverage Sales in Recreation Facilities and Local Government Buildings

 Phase 1 of this program was launched and 9 communities have been approved
- Built Environment & Active Transportation Community Planning Grants – over 50 Expressions of Interest were received and staff expect 10 to 12 communities to receive project approval
- Local government employee health promotion project and "Active Civic Employees" website launched with 2010 Legacies Now

First Nations

- regional Community to Community Forum program – 48 applications were received for the 2007/08 program and 39 events were held. Provincial funding maintained and federal funding increased for 2008/09 program. To date, 28 applications for 47 events have been received
- supporting Treaty Implementation Pilot Project program – 4 applicants were approved for pilot projects and applications will continue to be reviewed
- Treaty Knowledge Exchange Dialogue program

 To date, 4 applicants have been approved in principal. Applications will be reviewed on an on-going basis

First Nations Relations, Treaty Negotiations and the New Relationship

Over the past year, UBCM continued to provide policy support to local governments on treaty negotiation issues and to strengthen relationships between local governments and First Nations. In addition, the First Nations Relations Committee focused its work on establishing a role for local governments in the Province's New Relationship activities with First Nations.

New Relationship

UBCM is seeking active consultation on New Relationship agreements that the Province is negotiating with First Nations outside the treaty process that have the potential to affect local government jurisdiction. UBCM has been working with the Ministry of Aboriginal Relations and Reconciliation (MARR) on drafting a revised memorandum of understanding that will define a role for local governments in the New Relationship.

Information Sharing and Relationship Building Activities

In 2007 UBCM received \$300,000 from MARR to undertake information sharing and relationship building activities relating to the three final treaty agreements that were initialed in 2006. With this funding UBCM is administering two programs:

• Treaty Knowledge Exchange Dialogue program provides funding for treaty advisory committees (TACs)/ local governments involved in treaty negotiations to meet with and learn from other TACs/local governments who are involved in more advanced negotiations.

• Supporting Treaty Implementation Pilot Project program provides funding to TACs/local governments who are undertaking initiatives that support treaty implementation.

Other information sharing activities that UBCM is working on include

the research and writing of a case studies handbook on local government experiences in treaty negotiations. This handbook will provide information on promising practices and lessons learned.

Strengthening Local Government -First Nation Relations

At the 2007 UBCM Convention, a preconference session was organized that dealt with how local governments can work effectively with First Nations. Our main speaker, Bob Joseph, provided delegates with tools and tips for working collaboratively with First Nations. Also at this session, UBCM launched the Guide to Community to Community Forums in British Columbia, which was designed to assist communities in taking the first step in coming together in dialogue. The Guide was a collaborative effort among UBCM, Ministry of Community Services and First Nations Summit. The federal government also provided funding support.

Another issue of the C2C Connect newsletter was distributed in fall 2007. UBCM also continued to administer the Regional Community to Community Forum Program. Over the 2007/08year, close to 40 regional forums were held across the Province.

Treaty Focus

UBCM continued to advocate to the provincial government for improved funding support for local governments in treaty negotiations. UBCM also advocated for sharing of confidential treaty information among TACs.

UBCM provides support to local governments/TACs as needed. UBCM has supported information sharing among TACs/local governments through conference calls and TAC updates.

Enhancing Economic Development Opportunities

The terms of reference for the Community Economic Development Committee state that its primary focus is to improve regional economic development opportunities for local governments. Over the past year, the Committee has engaged in a number of policy areas that have a direct affect on the economic development potential of BC communities.

With respect to the pine beetle and the challenges that this presents for many forest communities, the Committee hosted a pre-conference session at the 2007 UBCM Convention which brought together Ministers Coleman and Lunn to discuss the provincial and federal responses to the pine beetle. As well, representatives from each of the Beetle Action Coalitions reported out on the work being done locally to plan for and assist communities in the years ahead.

Many local governments are looking to expand the economic development potential of tourism for their communities. UBCM has been working with the Centre for Tourism Development on a guide book to assist BC communities in identifying tourism opportunities as well as the "how to" of developing an effective tourism plan.

One sector of the tourism market that has been expanding is the recreational vehicle (RV) traveler. Today's RV'er is looking for greater and expanded services within park sites to accommodate both the size and the level of technology associated with their vehicle. The Province recently released a report outlining 15 recommendations for enhancing RV park development in BC. Three of the report's recommendations directly relate to local governments. Committee Chair, Councillor Mary Sjostrom, has agreed to be part of an inter-agency working group that will be providing input as to how best to implement the report's recommendations.

On other policy matters, the Committee reviewed the proposed new federal Fisheries Act (Bill C-45); met with provincial representatives on the oil and gas regulatory review initiative; received a delegation from the Canadian Community Economic Development Network; continue to monitor discussions related to Site C; reviewed and provided feedback on the BC Agricultural Plan as well as BC's Bioenergy Strategy; and engaged in discussions around the BC Energy Plan's recommendation related to energy conservation and efficiency.

The Committee also oversees the work of the MOU working group on Offshore Oil and Gas. The Committee has been represented by both Mayor Sharon Hartwell and Director Rod Sherrell as the Committee liaison, serving as Chair to the working group. The working group continues to make progress and will be preparing a report on its deliberations in the coming months, specifically identifying issues of interest to local governments.

This year the Committee has also taken on a monitoring role with respect to the Province's single business licence initiative. When presented at Convention in 2007, the Province had proposed a provincewide business licencing scheme. As a result of expressed local government concerns, however the initiative has since reduced its scope to a pilot project in the Okanagan for mobile businesses only, as part of Phase 1. The Committee continues to monitor the pilot, and quarterly reports on the project are reported in the UBCM News.

- Advise on the development of any new provincial product stewardship program to ensure that it adopts a fully industry funded framework which maximizes the recovery rate and provides the broadest choice of options for consumers; and
- Provide advisory support to the implementation of the Climate Action Charter where requested and appropriate.

THE GREEN AGENDA

Over the past year, the Environment Committee has been actively monitoring and advising on a number of key environmental issues which impact the sustainability and well being of local communities. From the Sewerage System Regulation, to contaminated sites, to product stewardship, the Committee has voiced local government concerns and recommendations on a number of key regulations, strategies and policies devised under the Province's "green agenda."

The Sewerage System Regulation (SSR) has been a key Committee issue this year as the Regulation has raised implementation challenges for local governments' throughout the province. In response to these onsite septic system issues, UBCM struck a working group of appointed elected officials and senior provincial staff to review the SSR and identify policy changes and/or regulatory amendments. The working group developed a seventeen (17) point action plan last Fall, and has been actively working to secure the deliverables within the plan. In September, the Ministry of Health will be initiating a communications strategy and holding regional workshops to outline changes made to the implementation of the SSR.

As part of its advocacy efforts, the Committee has been raising local governments concerns over the proposed interim site profile process for contaminated sites, as well as the handling of offsite contamination. In April, the Committee met with the Honourable Barry Penner, Minister of Environment, and discussed the need for full indemnification of local governments under the proposed process as well as the need to provide local governments with a reasonable ability to require timely remediation of onsite and offsite contamination. The Committee has also sought changes to the site profile process through formal submissions, staff representation on two contaminated sites working groups, and the holding of a joint UBCM-provincial government workshop that explored ways to accommodate local

government positions.

In accordance with the product stewardship framework adopted in the 2007 Environment Action Plan, the Committee monitored and advised on the creation of new, and the expansion of existing, product stewardship programs. In April, the Province announced its intention to add products containing mercury to the provincial Recycling Regulation, as well as the expansion of the list of electronic products included in the electronic waste product stewardship program.

The Committee has also been proactively working with the Province on its "green agenda." Through participation in the BC Brownfield Advisory Group, UBCM has been shaping the development of a new provincial brownfields renewal strategy that is designed to foster the redevelopment of abandoned and vacant sites with perceived or real contamination. Discussions were also held with the Province over amendments to the Wildlife Act, the provincial review of the Water Act, air quality standards, the plastic bags issue, and the proposed development of a Landfill Gas Regulation under the Environmental Management Act. The Committee also provided advisory support for the implementation of the Climate Action Charter, of which one hundred and twenty-four (124) local governments have signed.

In addition, the Committee continued its work with the Ministry of Environment on minimizing the impact of the Riparian Areas Regulation (RAR), and assisting local governments in achieving compliance with the Regulation. In June, the Ministry and the Department of Fisheries and Oceans signed off on the **RAR** Intergovernmental Co-operation Agreement, marking the completion of the last tool required for the full implementation of the RAR. Overall, the Environment Committee has been advocating local government interests on a wide range of regulations, policies, and strategies being devised under the Province's "green agenda."

New Measures Underway

The Community Safety Committee has focused on a number of broad issues during the past year. The Committee was successful in organizing a Crime Prevention Conference in 2008 that dealt with the development of integrated crime prevention plans, gang, drug and domestic violence issues. The Committee also met with Attorney General Wally Oppal and senior staff from the Ministry of Attorney General where it raised issues of concern to local government and received information on a number of new initiatives.

Over 170 delegates attended the twoday conference on crime prevention entitled "Building A Safer Community: Gangs, Drugs and Domestic Violence" that was organized by the Committee in cooperation with the Ministry of Public Safety and Solicitor General, Ministry of Community Services, Ministry of Attorney General and the RCMP. The conference looked at a number of important issues to enhance community safety:

• development of an integrated approach to crime prevention and crime reduction measures, using evidence based programs;

• crime prevention measures being undertaken by local communities;

• strategies for dealing with youth gang violence;

• drug issues facing local communities and strategies to mitigate the problems;

• community-based strategies to address domestic and sexual violence.

The Committee received an update on the activities of the Civil Forfeiture Office, which under the *Civil Forfeiture Act* is able to use the civil court process, to seek the forfeiture of proceeds of unlawful activity in British Columbia – money, property etc. The Civil Forfeiture Office has been successful in all of its actions to date and the proceeds from these cases can used to reimburse victims (i.e. fraud cases); administration of the Act; crime prevention and crime reduction activities. The province in 2008 announced that \$20 million dollars in funding obtained through proceeding under the *Civil Forfeiture Act* would be made available to local communities for crime prevention and crime reduction initiatives.

While in Victoria, the Community Safety Committee met with senior staff from the Ministry of Public Safety and Solicitor General and received an update on the RCMP contract discussions, the status of the new Police Recruitment Fund announced by the federal government, and the provincial response to the concerns raised regarding the sale of stolen property by pawnshops and scrap metal dealers. The Committee also met with Attorney General Wally Oppal and senior staff from the Ministry of Attorney General where it received a briefing on the Community Court system that the province will be opening in Vancouver in 2008; an update on the development of a provincial crime prevention strategy that is scheduled to be released in the fall of 2008; potential changes to the Bylaw Adjudication Court System; and the release of a comprehensive review of court sentencing in the province that is expected to be released this fall.

The Community Safety Committee received updates on new provincial funding for flood hazard management and continued to pursue the need for federal funding for flood hazard management. The Committee wrote to the federal government requesting that it match the provincial level of funding of \$100 million over 10 years to enhance flood protection measures announced at the 2007 UBCM Convention. The federal government has announced that it will provide \$60 million to flood hazard management to be financed out of the Building Canada Fund.

Standing Committees Report Out

Presidents

This past year has been one of transition. The Presidents Committee, mandated with the task of hiring a new Executive Director, undertook a recruitment process over the summer of 2007. On October 15, 2008 Gary MacIsaac became the new Executive Director while Richard Taylor continues as Manager of Victoria Operations until December 2008.

The Committee has continued with its three-fold mandate to: maintain and enhance organizational effectiveness; serve as hub for coordination between Vice-President liaisons to all UBCM Committees; and oversee projects that don't have a home within the established UBCM Committee structure.

Projects related to maintaining and enhancing UBCM's organizational effectiveness have included:

• completed a review and updated both Executive and staff polices

• established a UBCM Code of Conduct for Executive and staff

• established a new pay grid administration system

• contracted consultants to redesign UBCM website - civicnet.bc.ca

• partnered with Civicinfo on the Professionals Directory component of the 2008 Networkbook.

The Committee also provides oversight on the new Municipal House project and is pleased to report that construction has begun on the new LEED building at 525 Government Street in Victoria. Executive members were joined by the Honourable Ida Chong for the ceremonial "cement pouring" on April 11 in conjunction with our spring Executive meeting. While in Victoria, the Committee also met with the Finance Minister on the carbon tax and the Transportation Minister on the Building Canada Fund. The Committee has also taken the lead on providing oversight to the affordable housing and homelessness file which straddles many Committee mandates, as well as commissioning research work on the municipal fiscal imbalance.

The Committee also provides oversight for UBCM's Member Services and Group Benefits Programs, Community Excellence Awards, the BC Healthy Communities Initiative administrative functions, and our work in the area of international programs. UBCM representatives to the Municipal Pension Plan and the Pension Management Corporation also report to the Presidents Committee.

Convention

The 2007 Convention was held in Vancouver from September 24 - 28. A variety of tours and sessions were held, such as the always-popular Agriculture Study Tour and theme-related sessions on climate change. This diverse mix continued all week with clinics on mining, provincial sessions on the single business license initiative, and a workshop on "Living with Illiteracy" lead by Jacques Demers. A total of 1,986 people attended Convention – 1,246 of those representing 179 UBCM member municipalities and regional districts. Delegates rated the Convention well at 4.1 out of 5.0.

Resolutions

The annual resolutions process forms the foundation of UBCM's ongoing advocacy work on behalf of British Columbia's local governments. Resolutions are a means of speaking with one voice to express the needs and concerns of BC communities and often result in positive change for municipalities and regional districts throughout the province. Many members have asked, "do resolutions make a difference?" This report from the Resolutions Committee is designed to definitively state, "yes!"

Recent responses to several resolutions from the past two years provide examples of the kinds of success that can be achieved through this process:

• Addressing concerns raised in **2007** resolutions **B29** and **B70**, the 2008 provincial Throne Speech introduced a new "Brownfields to Greenfields" redevelopment strategy to target existing "dirty" sites for the creation of well-treed, green, livable communities.

• Resolution **2006-B73** was addressed through amendments to local government statutes extending mail ballot voting, where authorized by local bylaw, to snowbirds and other electors who will be absent throughout the voting period for local government elections.

• Resolution **2007-B130** called for local government authority to implement and require energy efficiency standards for new buildings, recent amendments to housing statutes grant this authority to local governments.

• Resolution **2006-B27** saw action in the form of the provincial Greenhouse Gas Reduction (Renewable and Low Carbon Fuel Requirements) Act, which requires that fuel suppliers have a prescribed percentage of renewable fuel in the fuel they supply.

• Resolution **2006-B118** was addressed through amendments granting local governments discretionary powers to waive or reduce DCCs for "green" developments (for-profit affordable rental housing; subdivisions of small lots designed to result in low greenhouse gas emissions; and developments designed to result in a low environmental impact).

These are some recent success stories. Other resolutions from years past may not have achieved immediate results, but nevertheless brought local government issues to the attention of the provincial and federal governments. Close to 100% of UBCM resolutions have received direct responses from provincial and federal ministries over the past several years – indicating that, while change is not always achieved immediately, UBCM's collective voice is heard loud and clear.

In 2008, member resolutions reflect a wide variety of local government contexts and concerns, and respond to provincial and federal initiatives and legislation. Climate change issues and local government fiscal concerns are paramount for many members, as local governments consider the new provincial carbon tax. Community safety and policing issues are once again of key interest to the membership, with transportation, the environment, and economic development also remaining top priorities for local government.

Building Healthy Communities

Over the past year, the Healthy Communities Committee has continued to work on health related policy development and collaborate with local governments around the province in proactively addressing community health problems.

Health policy work has included extensive consultations on Bill 23- a new Public Health Act. The implications of the new Act for local government were discussed in several meetings, including a meeting in March 2008 between UBCM President Susan Gimse, and the Ministers of Health and Community Services. UBCM has continued to advocate for local government interests and Bill 23 sets out a new role for local governments in section 83, which is limited to;

1) Acting on health hazards by taking one of the following three actions if the local government becomes aware of a health hazard

- reporting the hazard to the MHO; or

- taking action if it has been delegated authority under the Act; or

- taking action if it has the authority under another Act such as the Community Charter or the Local Government Act.

2) Designating a liaison to the regional Health Authority

3) Requesting a MHO or provincial health officer to issue an order regarding a health hazard

In addition, under this Bill, Medical Health Officers are required to consult local government if they intend to report on a public health issue affecting local government; Cabinet can establish processes to resolve disputes between local governments and Health Authorities; and public bodies that are ordered to prepare a health plan are required to consult with local government.


UBCM has received communication from many of our members regarding the adequacy of health services throughout the province and the implications for an aging population. UBCM membership has previously endorsed several resolutions on the topic of Home Support, that have generally called for the provincial government to ensure access to and adequate funding for home support programs throughout the province. UBCM has prepared a policy paper on Home Support for aging populations for review at this year's Convention.

Since 2006, UBCM has considered ongoing member concerns on the topic of local government relations with Regional Health Authorities. This year, a consultant was selected and a Review of the Implementation of Recommendations of the 2003 Regional Hospital District Cost-Sharing Review has begun. The consultant will be presenting the results in late October.

Health promotion and disease prevention initiatives continue with work on the Provincial Health Services Authority's Health and the Built Environment Project; support for the BC Healthy Living Alliance; and our Local Government Program Services grant management on Healthy Food & Beverage Sales, Seniors' Housing & Support Initiatives and Built Environment & Active Transportation Plans.

Food security continues to be another critical component of healthy communities. UBCM, Provincial Health Services Authority (PHSA) and BC Healthy Communities have jointly prepared a resource book for local governments on their role in food security in their communities. UBCM also participates in the Community Food Action Initiative, led by the PHSA, as part of ActNowBC.

The Committee also reviewed the Tripartite First Nations Health Plan; the Food Premises Regulation; reports on the ambulance service and first responders as well as the Conversation on Health.

Local Government Program Services

....programs to address provincial-local government shared priorities



BCM has been delivering a number of provincially funded programs since 2004. Building on the successes of previous years, we have received an additional \$16 million in support of new or expanded community programming. These funds

- Building Governance Capacity \$300,000
- Built Environment & Active Transportation \$425,000
- Farmed Animal Mass Carcass Disposal \$350,000
- Healthy Food & Beverage Sales \$600,000
- Regional Community to Community Forum \$120,000
- Seniors' Housing & Support Initiative \$500,000
- Strategic Wildfire Prevention Initiatives \$9.8 million
- West Nile Virus Risk Reduction Initiative \$4 million

This is the fourth annual report to members on LGPS programs. Regular programming updates are also available through the UBCM Newsletter and by contacting the LGPS office. Program status reports and the annual Premier's Report also provide detailed information on LGPS programs and their effectiveness in communities.

This year's financial statements include audited accounts for the funds received, amounts disbursed and fund balances. More detailed expenditures and our accounting policies are available on the Civicnet website. It is important to note that LGPS funds are completely separate from regular UBCM accounts.

The following is a summary of the types of activities that have been undertaken by UBCM's members through funds administered by LGPS on behalf of the province.

Building Governance Capacity

Administered for the Ministry of Aboriginal Relations & Reconciliation (\$300,000/ 2008) This program was developed in 2007 to assist local governments and First Nations that have an established working relationship to address specific capacity gaps related to governance issues. Matching grants of up to \$25,000 are available to help local governments and First Nations to work together on common governance-related issues, participate in capacity building activities or events and, at the same time, build governance management skills, knowledge, abilities and understanding.

Built Environment & Active Transportation

Administered for the BC Healthy Living Alliance (\$425,000/ 2008)

Phase 1 of this program provided community planning grants to local governments to develop new plans or amend existing plans for active transportation infrastructure. The purpose of the program is to better position local governments to secure and more effectively utilize existing funding opportunities offered through provincial and federal government programs, and other funders, that require local governments to have a plan in place. Phase 2 will be available in 2009.

Community Health Promotion Fund

Administered for the Ministry of Health (\$5 million/ 2004)

This program was created in 2005 to support health promotion programs and activities in communities through a focus on healthy living and chronic disease prevention. To date, over

120 pilot projects have been approved and community and individual health promotion projects have taken in more than 80 communities.

Community Structural Protection Units

Administered for the Office of the Fire Commissioner/Ministry of Forests & Range (\$1 million/ 2004)

This program was developed in 2004 in response to "Filmon Report" recommendations after the fires of 2003. Four structural protection units were developed and are available for deployment in the event of a fire in the wildland urban interface. The units are managed on an on-going basis in cooperation with Office of the Fire Commissioner and Ministry of Forests.

Community Tourism

Administered for the Province of British Columbia (\$25 million/ 2005)

The Community Tourism program is in the second of a two-phase program designed to support communities to increase local tourism. Nearly every local government in the province has participated in this program, which has supported a broad range of activities such as planning and marketing, festivals and events, and small capital investments. The deadline for applications is November 30, 2008.

Farmed Animal Mass Carcass Disposal

Administered for the Minister of Agriculture and Lands and the Investment Agriculture Foundation (\$350,000/ 2007) Working with the Investment Agriculture Foundation this program was developed to assist communities wishing to develop an emergency plan for dealing with carcass disposal in the event of mass mortality. It is directed at communities with a large population of farmed animals that could be impacted in an emergency.

Healthy Food & Beverage Sales

Administered for the BC Healthy Living Alliance (\$600,000/ 2008)

UBCM and the BC Recreation & Parks Association worked in partnership to develop this program in 2008. Grants support local governments with the development and implementation of healthy food and beverage sales in recreation facilities and local government buildings. Nine communities received funding in Phase 1 and Phases 2 (2008) and 3 (2009) will support an additional 50 communities.

Regional Community to Community (C2C) Forum Program

Administered for the Ministry of Community Services and Indian & Northern Affairs Canada - BC Region (\$665,000/ multi-year and \$120,000/ 2008)

The Regional C2C program has provided opportunities for local governments and First Nations to come together in dialogue on topics of mutual interest or concern since 1999. In 2007/08, 37 events were held throughout the province and the spring call for 2008/09 applications generated close to 30 applicants.

School Community Connections

Administered for the Ministry of Education by UBCM and the BC School Trustees Association (\$10 million/ 2005) This program was launched in 2005 to encourage local governments and school districts to consider the use of underutilized schools in addressing joint community/school district needs. Projects funded under this program are now underway across the province.

A smaller scale program was launched in 2008 in support of projects that address both school and community needs, but focused on such issues as early learning, literacy, food security, and healthy kids and families. The deadline for applications is October 30, 2008.

Seniors' Housing & Support Initiative

Administered for the Ministry of Community Services (\$2 million/2004) and Ministry of Health (\$500,000/2007) Launched in 2004, the intent of this program is to assist local governments to prepare for an aging population by supporting the ability of BC's older adults to age in place. In 2007, age-friendly community planning and initiatives were added to both the pilot project and dialogue component of this program. To date, more than 50 pilot projects and more than 40 dialogues have received funding.

Strategic Wildfire Prevention Initiatives

Administered for the Ministry of Forests and Range (\$37 million/multi-year since 2004)

The Strategic Wildfire Prevention program is designed with three separate components. Communities can develop a Community Wildfire Protection Plan (CWPP); test fuel management methodologies and conduct public education programs with a small-scale fuel management pilot project; and implement larger scale fuel reduction programs. Over 80 communities now have CWPPs and are moving forward with fuel reduction initiatives. A First Nations element to the program is also available where there is Mountain Pine Beetle affected timber. This program is open to applications on an on-going basis.

Supporting Treaty Implementation Pilot Project Program

Administered for the Ministry of Aboriginal Relations & Reconciliation (\$100,000/2007)

The intent of the program is to demonstrate options and provide examples of initiatives that local governments are undertaking to support treaty implementation activities in their communities. Grants of up to \$10,000 are available for pilot projects that support treaty implementation through activities such as developing an agreement between a local government and First Nation, establishing a mentoring program, or undertaking a community education and awareness campaign.

Treaty Knowledge Exchange Dialogue Program

Administered for the Ministry of Aboriginal Relations & Reconciliation (\$150,000/ 2007)

This program provides small grants to encourage the exchange of knowledge, information and experience between Treaty Advisory Committees (TACs) and/or local governments that have participated in advanced stages of the treaty process and those TACs/local governments that are involved in earlier stages of the process.

West Nile Virus Risk Reduction Initiative

Administered for the Ministry of Health (\$17 million/ multi-year since 2005)

This initiative was developed to assist communities with mosquito control programs designed to reduce the risk of West Nile Virus occurrence. Available to both local governments and First Nations, allocations are determined by a formula based on population and level of risk.

Gas Tax/Public Transit Management Services Secretariat: Investing in Local Government Capacity and Infrastructure

Priorities:

- Funding approvals under Gas Tax Agreement's application based programs
- Secure funding for 2010/11 to 2013/14

UBCM continued to deliver funding under the Gas Tax Agreement's Community Works Fund and Tier 3 Strategic Priorities Fund, as well as funding under both the Public Transit Agreement and Public Transit Infrastructure Program. Total funding received from inception of the programs to June 30, 2008 was \$359.2 million (federal GTA funding: \$254.2; federal PTA funding: \$52.5; provincial PTIP funding: \$52.5), and we have delivered \$290.8 million of this to recipients. This represents delivery of 81% of the funding received to date.

In addition, while none of these funds have yet been expended, funding commitments from the first round of applications under the Gas Tax Agreement's application based programs were made this year, as follows:

A second intake of applications for funding under the General Strategic Priorities Fund and Innovations Fund was invited this year, with an April 30, 2008 application deadline. Funding decisions on these applications are expected to be made by the fall of 2008.

This year's highlight was the securing of an additional \$1 Billion in federal Gas Tax funding for BC communities for the years 2010/11 through to 2013/14. This was accomplished through a Gas Tax Agreement extension signed by President Gimse and Ministers Cannon and Chong on March 17, 2008.
