"A forum for consultation, analysis and communication between Local Government and the Province regarding the management of the Agreement under which the RCMP provide local police services in BC and to analyze and respond to changes that may be proposed from time to time by the Federal government and/or the RCMP and recommend changes to the Federal government and/or the RCMP that may be considered necessary or appropriate."

#### ARTICLE 18.0 – LOCAL GOVERNMENT CONTRACT MANAGEMENT COMMITTEE


- There will be a Joint Provincial-Local Government RCMP Contract Management 18.1 Committee (the "Committee") in accordance with this article.
- 18.2 The Committee will work towards the goal of providing an efficient and effective police service in support of the administration of justice to all municipalities in the province that receive policing services from the RCMP and to meet the evolving needs of policing in the Province.

- Build strong partnerships with the Province, RCMP and other relevant stakeholders.
